DISCUSS AND/OR APPROVE BIDS FOR SIDEWALK

Roe – Two weeks ago we received a bid from ARC Construction for 500 more feet of concrete sidewalk on south Orchard, to get the sidewalk up to the driveway to City Hall and Library. The bid came in at \$25,450.00. I got some clarification because I wanted to make sure he bid a

landing spot on driveway side so we can have a crosswalk, because the sidewalk is on the far side of the street. On the bid he has three handicap ramps as shown on plan. So that included two ramps for the driveway side and a single ramp for the opposite side of Orchard Street. So I got clarification on that, it's on the bid. We did talk about, he had \$2,500 for the silt sock that is for the erosion control. We talked through the benefits of that and he said Dennis, you can save \$2,500, it's a shallow ditch, it's all grass. It would be easier to do the final grading if they didn't have the silt sock. That's that black snack that you saw along the sidewalk going down Orchard hill and along Old Mill road. What it is, it's a sock full of bark to basically reduce the dirt that may be washed away from the excavation, but over in Teals Nursery, where the ditch is shallow they didn't put a silt sock there. So I'm going to propose that we approve the bid minus the \$2,500 for the silt sock and that will save us \$2,500, which could be spent towards the signs and painting of the white blocks that need to be done. So if you subtract \$2,500, the bid would be \$22,950.

Motion by Roe to approve the sidewalk bid from ARC Construction for \$22,950 by removing the \$2,500 charge for the silt sock. Seconded by Veach Lord AYE, Veach AYE, Roe AYE, Petty AYE, Icenhower AYE

The highest ones from that are traffic stops, juvenile situations, domestics, assaults, check well beings persons, we had a nasty dog bite on a juvenile. It was pretty gnarly and then there was something that kind of caught my attention, the Facebook post related to Highway 65 patrolling it. I just wanted to share that out of all of those incidents, 18 of those were related to 65. Whether that's us making traffic stops, a majority of those are like, calls, most of it related to other drivers not maintaining their lanes, or something along those lines. Greene County gave Fair Grove PD a vest for Officer Long. The vest does expire in about a year. So he went and they were able to fit him with something that fits to his size. Since it's going to expire in about a year, they went ahead and gave us that and they're not requesting a payment in return for that. Other than that, I think that's all I have for the past month. A couple of neat comments, one student said "I'm not old enough to vote, but I've been talking to my parents about this. I've been telling them why this is so important and encouraging others around them, even though the students themselves can't vote for this yet, they're encouraging others in the community to pay attention. There was another one who was just grateful for the opportunity to have something real to put in their experience for as they move forward in their future career. There were several who were like, I want to go into Marketing and this was really cool to be able to experience.

Icenhower – Well Kelly put together a really good slide for the presentation to them and I was amazing at some of the questions they asked.

Roe - I was too.

Icenhower – and how many questions were asked. I mean there wasn't what you would think of your typical teenage question. I was really. Kelly put this all together. I could almost give her a hug.

Veach – Students in High School, if they're given the opportunity to think as adults and not be treated like children, they will come up with good ideas.

Icenhower – It worked out real great.

Petty – I mean, you should have seen Richard at the end of their presentations. He almost got ahead of himself and tried to express his gratitude before they were all done. There was almost tears in his eyes, because he was so proud of the students.

Icenhower – You didn't have to tell that part.

Petty – Proud of the work that they've done. Proud to be from Fair Grove and just super proud of everything. So, Dennis has been working just as hard. He's on all the emails with Casey and Sara as well. She's going to be the Coordinator. They've printed all of the labels to go on the fliers today. So it's been a team effort.

Roe – It's been a team effort. Sara has been very heavily involved in answering questions.

Dennis – Contacted the bond attorney to make sure that what we're saying is ok.

Petty – Once we've approve this billboard draft, she's going to the one that reaches out on behalf of the City, which the attorney has approved that we can spend money on to get this posted for a couple of weeks. Like I've said it's been a team effort and it's been a lot of fun and I appreciate the board supporting this. We don't know how the vote is going to turn out but I think that we did everything we could.

Icenhower – Where the handicap was, we couldn't put on the ballot "no tax increase". The school can do that, but the City can't

Roe – On our information sharing, we can do that. That's what we've learned. We'll talk about the billboard after I've finished this. Any other comments about that project, working with the school.

Roe - "Fix It Fair Grove" was the slogan that we chose from the 4 teams. We had four different slogans and we liked this one that best, "Fix It Fair Grove" in big capital letters, NO TAX INCREASE and it's showing a storm water concrete box that needs repair or replacement. So this is what they are proposing to put on the electronic billboard. Any questions about it?

Lord – I like the "no tax increase" written on there. I mean that's just on social media and the phone calls that I've got about it, it's hey no more taxes. It is misinformation out there, it's a no tax increase. So I like it in big, bold letters.

Roe – When the three of us reviewed the four presentations, this is what we were looking for. One group really nailed this, the "no tax increase". Like I said we took ideas from each group. The slogan actually came from a different group.

Lord – I've had a conversation with several people already on this and as soon as we get into this, it's like "well on Facebook, so and so, it's taxes" so as soon as we can get to this "no tax increase" part of it seems like that's news and it helps. So I like it right there on the billboard.

Petty – So it will be on the billboard and also be on the mailers that go to every registered voter household.

Lord – You just can't put it on ballot?

Roe – You just can't put it on the ballot.

Icenhower – You just can't put it on the ballot.

Roe – In the ballot language.

Petty – Trying to get that familiarity with the language of the actual ballot question connected to no tax increase, so when they see that, general obligation you know bond, they'll know, oh this is that thing that I got, no tax increase and hopefully.

Lord – You're battling misinformation on social media, is what you guys are battling.

Roe – Exactly.

Lord – So hopefully this will help with that. I think it will look good.

Roe – I think it will help a long ways towards stopping that. Hopefully.

We've got a budget and I don't know how much is left in the marketing/publicity, but make sure whatever it costs, we can afford.

Petty – The plan was, the school as going to submit an invoice for the materials for printing to the city and that we would coordinate with the billboard company, getting this posted. The last I heard, the billboard was \$75 a week. So if we do it on the 7th, that's \$75 total dollars plus tax. So the budget, I think with what we have left, was a little over \$2,000. I think after the invoice for the materials, mailers and billboard, I think we'll be well beneath that budget.
