President's Report: Paul Davis (updates, announcements, rule reminders)

- 1. There will be an ice cream social here today at 1:30p.m. Sundaes with various toppings will be available. Sue Tatosian (A-12) has volunteered to assume Activity Committee responsibilities.
- 2. August 3rd will be the Annual Yard, Craft & Bake Sale held at the Pavilion. Sign up with Jan Misch at D-01.
- 3. August 10th will be the Regular Board Meeting at 10:00am. New Board member terms will start August 1st. Officers will be appointed August 3rd at a Board Meeting held solely for that purpose and signing of necessary legal documents.

4. <u>Leisure Time Pre-Approval Building Permits are required for all projects.</u> No exceptions. You should not install sheds, fencing, gazebos, etc. or commence any other project without having received this approved permit. Some will be subject to receiving a City Permit Approval. It is an owner's obligation to contact the City and see what they require. A copy of the City Permit must be provided to the park Architectural Committee.

5. Our Caretaker, Stephen Burger, has been employed by the park for one year now. Seasonal helpers Michell Moore & Rebekah Burger have assisted with some of the grounds maintenance. Michael Kuljis provides Clubhouse Maintenance.

6. Stop signs mean STOP! They don't mean only if you want to. They don't mean only if you see another vehicle. The sign also applies to electric bikes, ATVs, UTVs & golf carts.

7. "Golf carts, ATVs, UTVs, motorcycles should not be operated by children under the age of 16 on the roads & streets in LTRV Park unless they have a driver's license. Having an adult in or on the vehicle with an unlicensed/unpermitted child driver is not sufficient. This is a safety issue."

Please do not disregard this park rule!!! It has been happening frequently lately.

9. Dust Abatement is working well. Owners have been advised to NOT water the roads. Do not assume that it is okay to do because you see someone else doing it.

10. Maintaining Lots. It is the owner's responsibility to see that their property is kept in good repair and that the lot is maintained regularly. Notices were sent to all those in non-compliance.
