Take I-65 South to Exit 234 (Shelby County Airport)  
At the end of the exit ramp turn left onto Hwy. 87 (this turns into Hwy. 12)  
Travel on Hwy. 12 (approximately 1.5 miles) to stop sign  
Turn right on to Hwy. 22 - travel 2-3 miles to traffic light  
Turn left on Hwy. 119 South (Ralph Sears Memorial)  
Travel one mile - the gate to The American Village will be on the right  
Once you arrive on the property you will see directional "SAR" signs instructing you on where to go for the meeting.

If coming from the South:
