AGREEMENT FOR CONDUCT OF THE CITY OF HIAWASSEE ELECTIONS

This Agreement, entered into this day of March, 20 25, by and between the City of Hiawassee, Georgia (hereinafter "the City") and Towns County, Georgia (hereinafter "the County"):

WHEREAS, the City pursuant to O.C.G.A. § 21-2-45(c) has by ordinance authorized the County to conduct the City of Hiawassee Elections for the 2025 election year.

WHEREAS, the City has requested the County to perform the functions imposed on it by Title 21 of the Official Code of Georgia with reference to such Elections;

WHEREAS, the City has requested the County to be the Qualifying Officer for the City;

WHEREAS, the County is willing to perform the requested functions;

NOW, THEREFORE, in consideration of the mutual covenants, promises, conditions and agreements contained herein, the parties hereto do mutually agree as follows:

(1)

The City agrees to pay the County, for the service of its Board of Elections and Registration, in the conduct of the City of Hiawassee special called elections and regular elections held on the Tuesday next following the first Monday in November in 2025, all actual costs incurred in conducting said election (each, an "Election"). Said costs to include, without limitation, costs of publication; use of election equipment; cost of sample, absentee, provisional and duplicator ballot cards; costs of printing said ballots; area supervisor's salaries; election night personnel compensation; absentee voting staff salaries; advance voting space and staff salaries (if applicable); cost of training and compensation for poll workers.

(2)

The County shall perform, through its Board of Elections and Registration, the following functions with reference to the conduct of the aforesaid Election: (a) Election call and planning; (b) ballot layout for absentee and provisional ballots; (c) hiring of personnel; (d) special instructions to poll workers; (e) programming of election equipment; (f) preparation of elections list; (g) election day coverage; (h) election managers meeting; (i) audit of election results; (j) certification and consolidation of returns; (k) absentee voting; (l) advance voting (if applicable); (m) ordering and packing of supplies; (n) registration of voters; (o) training of poll workers; (p) all ethics filing; (q) necessary advertising; and (r) such other reasonable and necessary duties and services are required to conduct the Elections.

The City shall perform the function of qualifying candidates and shall notify the County in writing of each person who qualifies.

The Board of Elections and Registration and Supervisor reserve the right to determine the legal sufficiency of a notice and request for an election together with the discretion to manage and conduct elections in accordance with statutes and rules and regulations as may be established by the Office of the Georgia Secretary of State.

(3)

The City hereby agrees to release, indemnify and hold harmless the County, its Board of Elections and Registration, and their respective agents and employees from and against any and all loss, damage, injury, claims, expenses (including attorneys' fees and expenses and litigation) and demands arising out of or connected in any way with the conduct of the Election, which are not occasioned by any gross negligence on the part of the County or its Board of Elections and Registration.

(4)

In the event of a special, run off or rerun Election, the County will instruct its Board of Elections and Registration to invoice the City for all cost and expensed reasonably incurred in connection with the conduct of said Election. Pursuant to Section 5.13 of the City Charter of the City of Hiawassee a special election to fill a vacancy in the office of mayor or councilmember shall be held only if the city council or those remaining pass a resolution ordering such special election.

(5)

Execution of this document repeals and supersedes any previous intergovernmental agreement and/or documents. The terms of this Agreement shall not be altered, amended, or modified except in writing signed by duly authorized officers or representatives of the parties. This Agreement shall be exclusively for the benefit of the City and the County and shall not provide any third parties with any remedy, claim, liability, reimbursement, cause of action, or other right.

(6)

If any paragraph, subparagraph, sentence, clause, phrase, or any portion of this Agreement shall be declared invalid or unconstitutional or any portion of this Agreement shall be declared invalid or unconstitutional by any court of competent jurisdiction or if the provisions of any part of this Agreement as applied to any particular situation or set of circumstances shall be declared invalid or unconstitutional, such invalidity shall not be construed to affect the portions of this Agreement not held to be invalid. It is hereby declared to be the intent of the parties to provide for separate and divisible parts, and they do hereby adopt any and all parts hereof as may not be held invalid for any reason.

This Agreement shall be for a term from the date first written above through December 31, 2025. In addition, this Agreement may be terminated by either party by providing to the other party at least ninety (90) days prior written notice of termination at any time during the term; provided, however, that if it is within two (2) weeks of the qualification period for an Election such termination shall not be effective until the Election is complete.

The City will remit payment of an invoice for the costs of holding an election within thirty (30) days of the receipt of the same.

BE IT FURTHER RESOLVED that early voting shall be held according to law; and

BE IT FURTHER RESOLVED that the City Clerk is hereby directed to post the notices and run the advertisements required by law;
