It has been a full year that Pet Project for Pets is the Florida affiliate for the Rescue Bank, a program of greater good which is the National nonprofit organization that accepts and distributes pet food donated by pet food companies. Our job is to be the receiver, warehouse and distributor to the approved Florida nonprofits.

Pet Project for Pets as the Rescue Bank affiliate in Florida has received and distributed **559,000** pounds of pet food and supplies to **68** local 501 c3 pet rescues, sanctuaries and cat TNR groups.

Pet Legacy Program has been developed in a partnership with

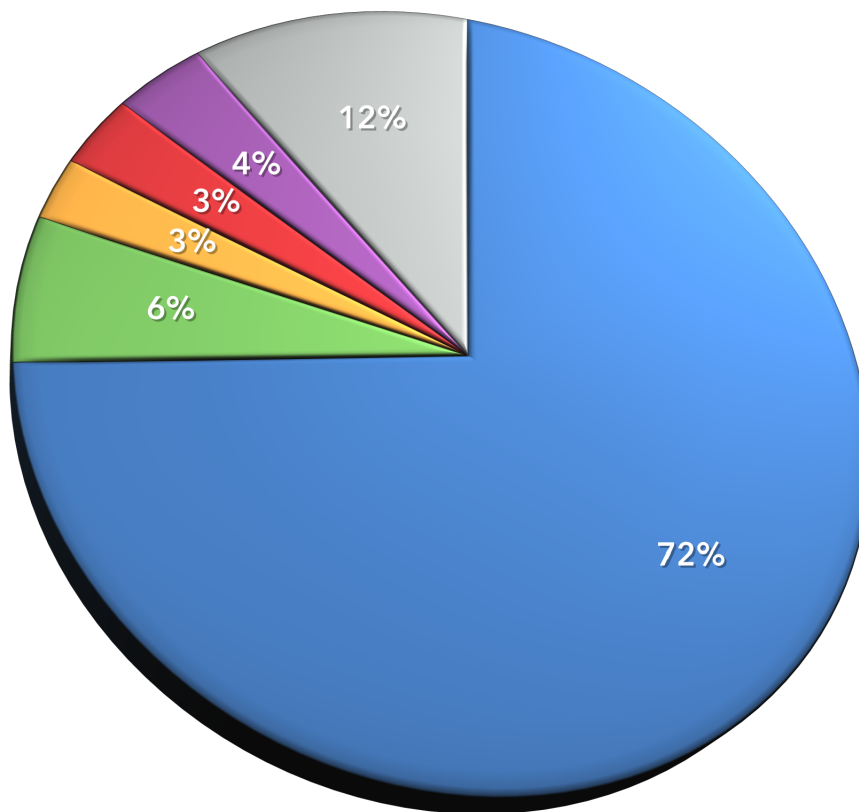
Our Fund and will be released in early 2017. The program is designed to provide a vehicle for people to set up a plan to provide for their pets in the event of their death.

- Veterinarian Care \$15,000 - 5.9%
- Vaccinations \$7,000 - 2.7%
- Special Diet Pet Food \$8,000 - 3.3%
- Transportation \$10,000 - 3.9%
- Administration \$30,000 - 11.8%
