ORDINANCE NO. 91-

AN ORDINANCE AMENDING ORDINANCE NO. 83-10 REGULATING TRAFFIC, STREETS AND SIDEWALKS WITHIN THE CORPORATE LIMITS OF THE VILLAGE OF CHAPIN

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. Ordinance 83-10, as amended, shall be amended by deleting Section 4 thereof, and inserting the following:

SECTION 4.

- (a) Stop signs shall be posted at the junctions of Cooper, Ash and Oak with Highway 104 such as to require traffic entering onto Highway 104 to stop.
- (b) A 4-way stop shall be located at the junction of Congress and Superior with stop signs posted such that all traffic traveling East or West on Superior and North or South on Congress shall stop.
- (c) Failure to stop, as posted, shall subject the violator to a \$10.00 fine.
- SECTION 2. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
- SECTION 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, such invalidity shall not affect any other sections, paragraphs, clauses or provisions herein.
- SECTION 4. All other ordinances, resolutions or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.
