

Privacy Statement

This Statement of Privacy applies to the Advocate Oil and Gas Web site and governs data collection and usage. Collection of your Personal Information

Use of Cookies

Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Advocate Oil and Gas pages, or register with Advocate Oil and Gas site or services, a cookie helps Advocate Oil and Gas to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
