#### **Sexual Violence: A Persistent Crisis**



Global health threat with limited progress in prevention and healing in the last 30 years.



of US women will experience sexual violence in their lifetime.



Sexual violence disproportionately affects marginalized groups. 3-9



Over 30% of girls and 10% of boys experience child sexual abuse. 10




Survivors require trauma-informed care for healing and justice. Only 21% access care.



### The Consequences: Devastating Outcomes

Sexual assault survivors experience higher rates of:

- PTSD
- Anxiety
- Suicidal thoughts
- Chronic disease
- Premature death
- Loss of productivity





Survivors are more likely to experience mental, physical, and socioeconomic challenges.



Sexual violence has steep societal costs with an estimated economic burden of \$3.1 trillion over the victimized individuals' lifetime.

# Purpose of the Medical Exam

- Assess overall child health and well-being
- Assess for injury
- Collect evidence if disclosure of recent contact (<72 hours)</li>
- Refer for services (counseling, medical follow-up)
- Reassure child and family



### Child-Focused

- Emphasize "whole child" during examination
- Allow them to touch items used during exam
- Give them some control (take their own pictures)
- Able to withdraw assent/consent at any time



### Examination is NOT painful



No child is ever forced to have an exam




## **SAFE-T System Technology**






The number of patients cared for doubled or tripled in first year of SAFE-T program at partner hospitals.






#### **Pre-Examination Worries**

#### I was worried about:

- Lack of control
- Being believed
- Being judged
- Being blamed
- The genital examination would be physically painful
- The examination would be embarrassing



### Patient Experience: During the Exam

Survey Question	n (%)
I felt in control	57/72 (79%)
I understood what was happening	64/73 (88%)
I felt believed	60/72 (83%)
I did NOT feel judged	64/73 (88%)
I did NOT feel blamed	64/72 (89%)
The genital exam was NOT painful	35/72 (49%)
I felt less embarrassed	49/72 (68%)





# Patient experience

Survey Question	n (%)
I could say no to any part of the exam	70/73 (96%)
My questions were answered	69/73 (95%)
The exam helped me feel better	70/73 (96%)
Having a telehealth consultation IMPROVED the care I received	66/72 (92%)




