This project includes Bid Package B – General Construction for bathroom remodeling;
Bid Package C – Carpet replacement, flooring and tile work, and library shelving relocation.
Bid Package D – Environmental work.

Bidders shall obtain and use complete sets of documents to prepare and submit bids.

Make proposals on the bid forms supplied in the Project Manual. No oral, telegraphic or telephonic proposals or modifications will be considered. Submit with each bid, a certified check or acceptable bidder's bond payable to Board of Trustees of the Fox River Grove Public Library in an amount equal to ten percent (10%) of the total bid. The successful bidder will be required to furnish satisfactory Labor and Material Payment Bond, and Performance Bond.

The successful bidder is required to pay not less than the general prevailing rates of wages to all laborers, workmen, and mechanics performing work under this contract, as ascertained by the Illinois Department of Labor, and shall submit certified payroll records, in compliance with the Prevailing Wage Act (820 ILCS 130) and shall comply with all applicable Illinois statutory requirements regarding labor, including Equal Employment Opportunity laws.

Bids may not be withdrawn within thirty (30) days after the scheduled time of opening bids, without the consent of the Owner. The Owner reserves the right to accept any bid or to reject any or all bids, or parts of such bids, and waive informalities or irregularities in bidding.

A PRE-BID MEETING will be held at Fox River Grove Memorial Library, 407 Lincoln Ave., Fox River Grove, Illinois 60021 on July 2, 2018 at 10:00 AM central time. Following the meeting bidders have an opportunity to review the area of work. Bidders are requested to attend, however, the pre-bid meeting is not mandatory. Bidders unable to attend may visit the site by appointment with the Construction Manager, Ken Frank, 847-740-2103.

The Owner requires Substantial Completion of the project on or before August 31, 2018.
