Mark DeCracker of 336 Pleasant Valley Road, Lyons and Cory Reynolds of 1569 Warncke Road, Lyons expressed concern over the deterioration of the murals in Newark. They would like to provide the Village of Newark a quote on restoration of the murals. The Village Board said they would take it into consideration but are not making a decision at the moment.

Robert & Elena Torres- Russell of 133 E. Maple Ave, Newark expressed concerns over the kids that have been causing issues within the Village lately. They were wondering what could be done or if the Village could impose a curfew. Attorney Art Williams said there would have to be a particular ongoing problem to legally set a curfew. Chief of Police Mark Thoms spoke about how they knew the problem and are doing everything that they can in their power. The Village Board suggested that they start a neighborhood watch program and also come to the Police Accountability Board meetings. The Village Board thanked them for coming to the meeting to discuss the problem with the Village.
