AN ORDINANCE NAMING STREETS

WHEREAS, the Corporate Authorities of the Village of Chapin, Morgan County, Illinois, deem it advisable to name certain streets that it has recently acquired jurisdiction over;

WHEREAS, the Illinois Municipal Code (65ILCS 5/11-80-19) grants the Village the authority to name originally and to change the name of any street, avenue, alley, or other public place;

WHEREAS, the portions of the streets located within the corporate limits of the Village of Chapin, Illinois, and designated as *Cylinder Head Rd*., **New Street**, and *Ore Rd*. on the attached <u>Appendix A</u> should be named as aforesaid

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, as follows:

SECTION 1: The portions of the streets located within the corporate limits of the Village of Chapin, Illinois and designated as Cylinder Head Rd., New Street, and Ore Rd. on the attached <u>Appendix A</u>, are hereby named respectively *Cylinder Head Road*., *New Street*, and *Ore Road*.

SECTION 2: The Village Clerk is hereby directed to immediately notify the election authorities having jurisdiction in the area where said streets are located, and the post office branch serving that area, of the naming of the streets in writing by certified mail, return receipt requested and by providing them with a certified copy of this ordinance.

SECTION 3: This Ordinance shall be effective upon its passage and approval as provided by law.
