The Colorado Tourism Board has just completed a 15-month effort to shape and brand eight new Colorado travel regions. Colorado regions once known by points on a compass (southeastern, south central) now have names reflecting the unique qualities that set them apart, not just from any other place in Colorado, but from any other place in the world.



For example, the part of Colorado dominated by one of the most massive and famous mountains in the U.S. — and includes the stunning landforms of Garden of the Gods, the Royal Gorge and the headwaters of the Arkansas River besides — is now Pikes Peak Wonders. Formerly it was known as South Central.

It's not much of a stretch to understand how new names like these will help understand the magnificent experiences that are in every corner of our remarkable state.

Note that the boundaries between the regions are intentionally blurry because what defines a region flows into the surrounding areas.

How does this affect us as tour guides? As we prepare our commentary for any region, we should think beyond that region. For instance, as we guide through Denver, we should share that Denver is also tied closely to the mountains while being home to the quiet plains. Share stories on the assortment of cities and towns that surround us –Aurora, Boulder, Fort Collins, Loveland, Greeley, and Estes Park. Each maintains its own unique character but has contributed to the Denver of today.

Rocky Mountain Guides Association, as a member of the National Federation of Tourist Guides Associations-USA, shares the goal of promoting the highest degree of professionalism for tour guides. At its February 2018 Board of Directors Meeting, the National Federation of Tourist Guides Associations adopted two additional codes. One of the two is

A professional tourist guide does not practice discrimination on the basis of race, gender, age, national origin, religion, sexual orientation or gender identity.

Leading a tour group is an honor for the professional tour guide. The guests have committed precious time and money to experience the sights and venues on the tour itinerary and expect to be treated in an appreciative manner. The professional tourist guide, therefore, welcomes all the guests in their assigned group, regardless of race, gender, age, national origin, religion, sexual orientation or gender identity.

By demonstrating appropriate behaviors, the professional tour guide models for all the guests a sense of inclusion that makes all the members of the group feel comfortable around each other and in their surroundings. As a result, both the tour guide and the guests recall their acquaintance as a memorable touring experience. Creating positive memories, after all, is at the heart of the professional tour guide's job.
