### New Business:

- Equine Vaccination Clinic with Dr. Essex is scheduled for March 19 in Yreka. The event will be open to members only. Members will pay for vaccinations. Dr. Essex is asking that the Unit cover his veterinarian fee for the duration of the clinic/day. He estimates this fee will be \$720-\$900 for the day, depending on the number of RSVPs. If the Unit covers this fee, then attending members would only pay for the vaccination costs. **Need a vote to cover this cost.**
- From BCHC BOD state meeting: Education committee asked Units to contribute to BCHC intern program to help extend the program to 12-14 weeks (up from 10 weeks). BCHC received a \$10,000 Forest Service grant to help with program, but they need \$8000 from Units for 2022 program. State Directors at the state meeting committed donation amounts between \$500 and \$3000 for a total of \$9000. **Do we want to contribute?** If so, make check out to BCHC Education Fund and send to Lynn Joiner at Bakersfield office. We can get the 2021 intern as a speaker (Contact Chip Herzig, Cindy McMurry or Stacy Kuhns for speaker).

IF THEY CHOSE TO COVER THEIR OWN TRAILERS AND CONTENTS Trailers up to \$8000.00 in value - 150.00yr. with 500.00 deductible

Equipment in the trailer up to \$50,000.00 in value - \$750.00/yr. with \$1000.00 deductible

The Executive Committee explored several options as to how to cover this increased cost. At the BCHC State meeting, it was voted that rather than raising dues or invoicing units for insurance, that we implement the following to cover the increased cost:

- 1. The State BCHC organization will pay the \$15,955 for insurance when invoiced
- 2. The State BCHC organization will continue to be responsible for \$7979 of the cost (approx. ½). \$7979 was the cost of insurance in 2021.
- 3. The remaining \$7976 when split over 1,922 members amounts to \$4.15 per member
- 4. The State will change the membership rebate to units as follows:
  - a. Individual Rebate is currently \$16.50 would be reduced by \$4.15 to \$12.35
  - b. Family Rebate (based on two members) is currently \$20 would be reduced by \$8.30 to \$11.70
