TRUMP ADMIN LOOKS AT DEEP CUTS TO HOMELESS HOUSING PROGRAM

The Trump administration is expected to dramatically cut funding for a permanent housing program — a move that could potentially reexpose tens of thousands of people to homelessness.

More than half of the 2026 funding for the Department of Housing and Urban Development's homelessness program designated for permanent housing projects will be cut and moved to transitional housing assistance with some work or service requirements, according to three HUD employees and a person with inside knowledge of the Continuum of Care program as well as internal HUD documents obtained by POLITICO confirming the cuts. All the people were granted anonymity to discuss sensitive matters.

The funding cuts could put more than 170,000 people at risk of experiencing homelessness, according to the internal documentation and the people.

"When the subsidy and the support that goes along with those subsidies is removed, it puts people at grave risk," said the person with inside knowledge of the CoC program. "And most of these folks without these supports will likely end up back in emergency shelters or back on our nation's streets."

The program partners with communities to provide housing and services to sheltered and unsheltered people with the goal of moving them into permanent housing. It often benefits families with children, and those who have experienced homelessness in the past in combination with being chronically ill or having a disability. The cuts could have a greater impact on rural areas that have less access to city and state dollars to supplement federal funding, the people said.

"HUD is no longer in the business of permanently funding homelessness without measuring program success at promoting recovery and selfsufficiency. There will be more news on this much needed paradigm shift soon," said a HUD spokesperson.

The change to the policy is the latest example of how the Trump administration is placing new rules on government benefits, often requiring work or other requirements for people seeking to tap federal subsidies. But those close to the program say the new policy could have severe repercussions, leaving those utilizing these services in a more dire situation if they have young children at home or are unable to work for a reason not recognized by the government as an exemption. Currently, 87 percent of all CoC program funds ending in 2026 are slated to support permanent housing in some capacity. Under the policy change, only 30 percent of the funds will be allowed to be used for that

I WAS HOMELESS. TRUMP'S PLAN TO CRIMINALIZE PEOPLE LIKE ME WON'T MAKE YOU SAFER.

When I moved from New York to Miami for my new job in information technology, my future seemed bright. Four months later, the firm downsized and I was let go, setting off a chain of events that left me homeless. I was homeless

in Miami for two years, and I spent 10 months in a homeless shelter in New York City.

Growing up in Freeport, Long Island, where my family and I overcame redlining and school segregation, I was an honor-roll student and earned an athletic

scholarship to study business and restaurant and hotel management before I pivoted to IT.

Homelessness taught me that being unhoused is not a personal, moral failure. Homelessness is a market failure, a housing

SPOT LIGHT— TOOF—THE OTHER ONES FOUNDATION

Driven by a mission to invite our unhoused neighbors into an engaged community, TOOF has been offering humanitarian aid, case management, and extremely lowbarrier employment opportunities to people experiencing homelessness since 2018. The Other Ones Foundation was born out of a desire to find new and innovative approaches to serving Austin's homeless community. TOOF's origins involve a deep dive of outreach and interviewing in encampments, asking unhoused people what THEY felt was missing from the homelessness re-

sponse system. In our initial encampment outreach, our most common finding was that people felt directionless and disempowered to connect with their community during the day, while waiting to get into shelters or access other services. This gave way to our Workforce First Program, which offers unhoused people an extremely low barrier opportunity to get a day's work. The dignity and empowerment of working in a group setting and giving back to your community, complimented by income and case management, serves as a major stepping stone to getting

our homeless friends on the path to a more fulfilling life.

St. Paul woman facing homelessness after housing program accused of fraud

The woman, who did not want to be identified due to the personal nature of her ordeal, said she found her downtown apartment via Housing Stabilization Services – a program the state shut down in August after the FBI raided multiple properties as part of a wide-ranging fraud investigation. In the case, eight suspects have been charged with federal crimes, and prosecutors said they expect to charge additional suspects.

Another state housing program,

Integrated Community Supports, provided the woman with housing services. But when that program became the target of fraud allegations in September, the Minnesota Department of Human Services stopped paying 11 providers.

Now, the woman must find another place to live. She said she will likely end up homeless – again. Audits preceded funding pull, provider says

"For three years now, I have been grounded, and life was finally feeling very comfortable and normal, and now it's thrown back out on the street and homeless again," she told FOX 9.
"Zero compassion, zero consideration, zero thought. And it is – the human cost is huge. It's huge, and this time it's my life."

"He did say that he had been audited six times in the last two years, which is beyond excessive, and that nothing was ever found in all of those six times and yet funding was pulled while the DHS memo that they put out said, 'If you can provide proof there's no fraud, we will reinstate your funding,' which has yet to happen for him," she says.

problem. Rent prices have exceeded income gains by 325% nationally since 1985. Rates of homelessness are tied to rental affordability. Here in New York City, in 2023, rents skyrocketed, more than seven times faster than wages, the largest gap in the country. Stigma distorts these truths. The White House's recent moves toward the criminalization of homelessness and forced institutionalization ignore decades of

research and real-world outcomes. They reject proven models like permanent supportive housing and will raise costs in lives and tax dollars for communities nationwide. Permanent supportive housing emerged in the United States three decades ago with bipartisan support, then championed by the George W. Bush administration as a solution to chronic homelessness, rooted in a philosophy called Housing First. Housing First stabilizes people experiencing homelessness in permanent housing and provides them with case management support and social services based on the theory that housing stability is most people's prerequisite for success. Crucially, Housing First does not require mental health treatment, sobriety or a job. It is difficult to focus on recovery for people living with a disability when they do not know where they will sleep tonight, and I know firsthand how hard it is to search for a job without a mailing address.

Word on The Street— Lawyers who hit L.A. City with whopping bill on homeless case to get millions more

The Los Angeles City Council on Wednesday approved a fivefold increase to its contract with a law firm that drew heated criticism for the invoices it submitted in a high-stakes homelessness case.

Three months ago, Gibson, Dunn & Crutcher billed the city \$1.8 million for two weeks of legal work, with 15 of its attorneys billing nearly \$1,300 per hour. By Aug. 8, the cost of the firm's work had jumped to \$3.2 million.

The price tag infuriated some on

the council, who pointed out that they had approved a three -year contract capped at \$900,000 — and specifically had asked for regular updates on the case.. Despite those concerns, the council voted 10 to 3 Wednesday to increase the firm's contract to nearly \$5 million for the current fiscal year, which ends in June 2026. Councilmember Katy Yaroslavsky supported the move, saying Gibson Dunn's work has been "essential to protecting the city's interests."

"At the same time, we put new oversight in place to ensure any additional funding requests come back to council before more money is allocated," said Yaroslavsky, who heads the council's budget committee.


A Gibson Dunn attorney who heads up the team that represents the city did not immediately respond to a request for comment. Meanwhile, an aide to City Atty. Hydee Feldstein Soto welcomed the council's vote.

FAMILY PROMISE NONPROFIT OPENS COMPLEX FOR FAMILIES EXPERIENCING HOMELESSNESS

Tonya Jones was days away from being evicted when she began scouting out bridges and tunnels around Southern Nevada where she and her 3-yearold daughter could potentially sleep if they couldn't find a place to stay. Jones had been able to work from home since the pandemic. But in the summer of 2022 when she unexpectedly lost her child care, she couldn't make it to work, lost her job, and quickly fell two months behind on rent. "I found a job in the middle of September, a week before my

actual eviction day," she said.
"I just needed a little bit more time." On a rainy September morning as a lockout of her apartment loomed, Jones remembered calling and emailing countless resources looking for help when she stumbled upon Family Promise of Las Vegas, a nonprofit that provides shelter and support services for families and children experiencing homelessness.

The organization put Jones and her daughter in an extended stay motel for the next several weeks until she was able to save up money and move into her own place. Jones, 43, and her now 6-year-old daughter, have been stably housed ever since. The number of families experiencing homelessness has grown over recent years in Southern Nevada, but there aren't a lot of shelter options, especially private rooms, available for them, said Family Promise's chief operations director, Marisa Cervantes.
