SCENES: Introduction w/banner

Criminal is in the process of stealing vault, Criminal encounters security, Criminal pulls out a gun, shoots, kills person, Criminal laughs at crime deed, Criminal hears sirens and runs, Criminal gets caught and placed in jail, Criminal is disparate, wants out, (hand cuffed),

Lawyer is assigned to Criminal, Lawyer comes up with a story to absolve crime, Criminal and Lawyer conspire an alibi,

Prosecutor enters chamber, mean-looking Prosecutor has suitcase, slams it on table, startles everyone...

Prosecutor gives the Criminal the evil-eye and with finger to throat, motions an "execution" and grins!

Criminal panics and pleads with his Lawyer for assurance, Lawyer reassures Criminal of ability

Judge enters courtroom, Judge strikes gavel twice, Judge motions the session to begin,

Prosecutor recounts the actual rendition, Prosecutor demands guilty plea and execution,

Lawyer tells of Criminal's social problems,
Lawyer shows smiling face of Criminal,
Lawyer tell of hunger,
Lawyer tell of large family,
Lawyer works up the court (weeping),
Lawyer hands out handkerchiefs to all,
Prosecutor snaps court to attention,
Prosecutor reminds the court of the evidence,

Judge steps out to center, turns around facing wall Judge becomes a "human balance" Judge weighs evidence (hands stretched out),

Lawyer stacks up his evidence (one sheet), Balance tipped ever slightly in favor of Criminal, Criminal and Lawyer rejoice at evidence, (hi-fi),

Prosecutor stacks up his evidence, (tons), Balance is tipped against Criminal dramatically, Criminal panics as found guilty by the "law", Lawyer packs up, exits chamber, shrugs shoulder toward Criminal... "sorry"....

Executioner enters.

Executioner takes Criminal to execution place, (chair or stool).

Executioner places head of Thief on "block", Executioner about to carry out death sentence,

CHRIST from the sidelines has been pondering all along, Christ intervenes and interrupts time with arm raised as sword of Executioner was about to go down...

(Music is paused)

Christ places the BIBLE on the balance, Bible tips the scale in favor of the Criminal, Christ takes off his royal robes, places on balance Christ takes the criminals, Criminal is set to the side, unbinds bands Christ embraces Criminal aside Christ voluntarily binds Himself Christ takes the position of execution Christ is executed instead.

(Music is continued where left off...as sword comes down)

Executioner and Christ exit stage, covered by cape Criminal's hand cuffs brake loose, Criminal ponders, takes Bible off of balance, Balances do not move, Criminal reads Bible verse, Criminal looks up to Heaven, recognizes work, repents and prays to get saved on his knees...extends arms upward and receives "new" life...

MORAL OF STORY: The LORD came to set the Captives Free... We are guilty before the law but the LORD paid the price to set the captive free.





