**KIT CARSON COUNTY SERVICES DURING COVID-19**

In an effort to slow the potential spread of COVID-19 in our community, Kit Carson County government will be closing public access to buildings **starting on Wednesday, March 18, 2020 at 8am.** Staff will be providing limited essential services by appointment or via phone and online avenues. In-person contact for receiving essential services will have limited restrictions during this time. **These adjustments to county services and public access will be in place until a further notice.** These precautions will be continually evaluated and may be subject to change.

Operation changes include the following Kit Carson County Government Departments and will be updated as new information related to the COVID-19 situation becomes available.
