Monthly Report for October 2019

This is the monthly report for the Month of October 2019 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Tuesday, October 1st at approximately 5:00pm officers received a bail jumping complaint. At the conclusion of the investigation a charge of bail jumping was forwarded to the Walworth County District Attorney's office for the 28-year-old female who was under conditions of bond when the violation occurred.

On Saturday, October 5th at approximately 11:00pm officers received a theft complaint which occurred from the Rock Bar located on Powers Lake Road. At the conclusion of the investigation non-traffic citations were issued to a 61-year-old female and a 27-year-old female for theft -movable property.

On Sunday, October 6th at approximately 9:53pm officers responded to the area of Hwy B and Speckman-Leedle Road for a single vehicle roll over property damage only crash. At the conclusion of the investigation a 16-year-old female was issued a citation for inattentive driving.

On Monday, October 7th at approximately 1:58pm officers responded to a single vehicle roll-over personal injury crash which occurred on Hwy 12 in the area of Clover Road. At the conclusion of the investigation, the driver, a 20-year-old male was issued traffic citations for driving too fast for conditions and operating after suspension. The driver was transported to an area hospital for non-life-threatening injuries sustained during the crash.

On Sunday, October 13th at approximately 3:23pm officers responded to a residence in the 1400 block of Sunset Drive for a domestic disturbance. At the conclusion of the investigation charges of disorderly conduct and bail jumping have been forwarded to the Walworth County District Attorney's office for a 34-year-old male. Charges of battery and disorderly conduct have also been forwarded for a 28-year-old female.

On Monday, October 14th at approximately 4:49am officers executed a traffic stop on Nippersink Rd in the area of Powers Lake Road for a speeding violation. At the conclusion of the traffic stop a 52-year-old male was issued a traffic citation for a speeding violation. Additionally, a charge of operating after revocation was forwarded to the Walworth County District Attorney's office.

On Monday, October 14th at approximately 2:05pm officers executed a traffic stop on Hwy H at Townhall Road for a registration violation. At the conclusion of the traffic stop a traffic citation was issued to a 60-year-old male for operating a motor vehicle without insurance. Additionally, a charge of operating after revocation and ignition interlock device tampering/failure to install have been forwarded to the Walworth County District Attorney's office.

On Tuesday, October 15th at approximately 2:08am officers responded to the 1400 block of Chicago Dr. for a disorderly person complaint. At the conclusion of the investigation a 23-year-old male was arrested

and confined in the Walworth County Jail. A charge of disorderly conduct has been forwarded to the Walworth County District Attorney's office.

On Friday, October 18th at approximately 6:10am officers executed a traffic stop on Pell Lake Dr. in the area of Daisy Drive for an equipment violation. At the conclusion of the stop a 32-year-old male was issued traffic citations for operating a motor vehicle without insurance and operating after suspension.

On Saturday, October 19th at approximately 6:55pm officers responded to a residence in the 600 block of Hafs Road for a domestic disturbance. At the conclusion of the investigation charges of battery and disorderly conduct have been forwarded to the Walworth County District Attorney's office for a 27-year-old female and a 22-year-old male who were involved in the incident.

On Wednesday, October 30th at approximately 1:55am officers executed a traffic stop on Hwy 50 in the area of Eastside Road for a speed violation. At the conclusion of the traffic stop a 32-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued a traffic citation for the speed violation.

On Wednesday, October 30th at approximately 5:41am officers responded to the 1600 block of Mallow Place for a report of disorderly subjects. At the conclusion of the investigation a charge of disorderly conduct has been forwarded to the Walworth County District Attorney's office for a 34-year-old female and a 34-year-old male who were involved in the incident.

On Thursday, October 31st at approximately 7:21pm officers responded to the 1200 block of S. Lakeshore Dr. for a disorderly male subject complaint. At the conclusion of the investigation a 35-year-old male was arrested and confined in the Walworth County Jail. Charges of disorderly conduct, criminal damage to property and criminal trespass to dwelling have been forwarded to the Walworth County District Attorney's office.

During the month of October 2019, the police department affected 133 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 141 arrests during the month of October 2018.
