

**AN ORDINANCE OF THE VILLAGE OF INNSBROOK, MISSOURI,  
NAMING VARIOUS PRIVATE ROADS IN THE VILLAGE OF  
INNSBROOK.**

WHEREAS, the Board of Trustees of the Village of Innsbrook have been requested to name a private road within the Village which is north of Leprechaun Lane to make the properties on said private road easier to locate; and

WHEREAS, since properties located on said private road are addressed with the Warren County Assessor's Office as "Hwy. F" the Board of Trustees of the Village of Innsbrook has agreed to place a road sign at the intersection of Hwy. F and said private road and to name the private road "Hwy. F Drive"; and

WHEREAS, the Board of Trustees was additionally requested to rename the road at the western end of Hwy. F Drive which bears to the south and as "Elysium" without a road suffix; and

WHEREAS, the Board of Trustees has corresponded with property owners on Hwy. F Dr. and Elysium and they are agreeable to said request; and

WHEREAS, the Board of Trustees, at their meeting of May 13, 2014 agreed that the request to place signage on said private roads would be in the best interest of the Village of Innsbrook.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF INNSBROOK, MISSOURI, AS FOLLOWS:

SECTION 1: The private roads located north of Leprechaun Lane shall hereafter be named "Hwy. F Drive" and the name of the road at the western most portion of Hwy F Drive which bears to the south shall be named "Elysium" as shown on the Exhibit "A" attached hereto is hereby approved.


SECTION 2: The properties, as they appear in the records of the Warren County Assessor's Office and referenced in this ordinance, are as follows:

SECTION 4: A copy of this ordinance shall be provided to the Warren County 9-1-1 Joint Communications, Wright City Post Office, Warren County Recorder of Deeds, Warren County Assessor's Office, Warren County Collector, Warren County Clerk, Department of Revenue, Warren County Planning & Zoning, Centurylink, Wright City Post Office, Wright City Fire Protection District, Warren County Sheriff's Department, Warren County Ambulance District as well as the property owners above stated.

SECTION 5: This ordinance shall be in full force and effect from and after its passage and approval by the Board of Trustees this 13th day of May, 2014 after having been read by title two times prior to passage.

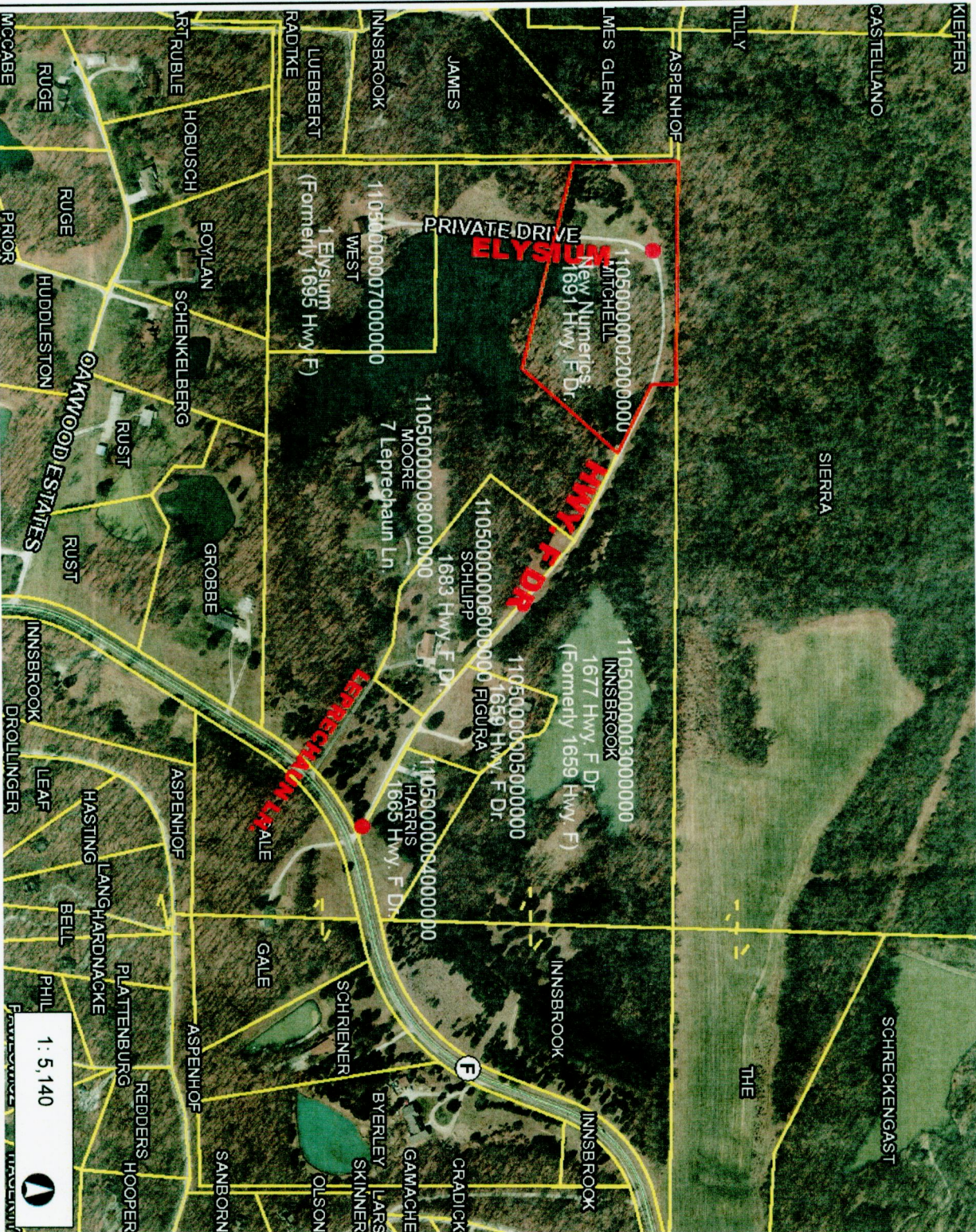

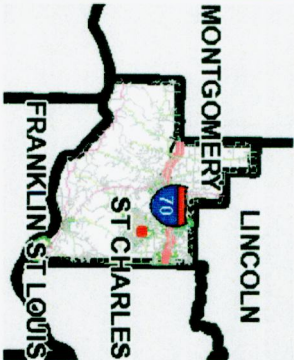
