

What information do we collect?

We collect information from you when you place an order, respond to a survey, or apply for membership.

When ordering or registering you may be asked (when appropriate) to enter your: name, email address, mailing address, phone number, credit card information or professional title. However, you may visit our site anonymously at any time.

What do we use your information for?

Any information we collect may be used in the following ways:

- To personalize your experience (your information helps us to better respond to your specific needs)
- To improve our website (we continually strive to provide the best possible website experience based on the information and feedback we receive from you)
- To improve customer service (your information helps us to better respond to any customer service requests and support needs)
- To process transactions (your information will not be sold, exchanged, transferred, or given to any other company, for any reason, without your consent. It will only be used for delivering products and/or services requested.

- To send periodic emails (the email address you provide, may be used to send you information and updates that are pertinent to your order, company news, or other service information)

How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information when you place an order, and enter, submit, or access your personal information.

We offer the use of a secure server. Any sensitive/private information is transmitted through Secure Socket Layer (SSL) technology. Any payments made on this site for products or services, are handled entirely by PayPal and thus protected by the same security measures that PayPal uses.

Once a transaction is made, your private information (credit cards, social security numbers, financials, etc.) will not be stored on our servers.

Do we disclose any information to outside parties?

We do not sell, trade, or otherwise transfer any of your personally identifiable information to outside parties. This does NOT include trusted third parties assisting us in the operation of our website, conducting MoSALPN business, or providing services to you.
