GENERAL CONTRACTOR AND OTHER TRADES (GC) SHALL ADHERE TO SPECIFICATIONS AS DETAILED IN THE FOLLOWING PAGES AND IS SOLELY RESPONSIBILE TO VERIFY SITE CONDITIONS AND FOR THE FINAL FIT AND

FINISH OF CABINETRY. IT IS THE SOLE RESPONSIBILTY OF THE GC TO CONFIRM AND VERIFY ALL APPLIANCE SPECIFICATIONS AND FIXTURE SELECTIONS AND VERIFY ALL SMALL APPLIANCE SIZES.

DISCUSS WITH ELECTRICIAN THE DESIRED COLOR AND TEMPERATURE OF ALL FIXTURES (CAN LIGHTS, UNDER-CABINET LIGHTS AND HANGING OR SURFACE-MOUNTED FIXTURES) MATCH; IF DESIRED. FINAL INSTALLATION OF CAN LIGHTS AND HANGING FIXTURES MAY VARY BASED UPON SITE CONDITIONS.

ALL FLOOR TILE SELECTED IN SHOWER MUST BE 3" X 3" OR SMALLER. FLOOR TILE MUST HAVE APPROPRIATE SLIP COEFFICIENT FOR WET AREAS. GROUT COLOR TO BE SELECTED ON JOBSITE AND SUPPLIED BY CONTRACTOR. GC MUST ALSO CONFIRM UNIFORMITY OF MATERIALS COLOR BEFORE WORK IS SCHEDULED TO BEGIN, IF PARTS ARE DAMAGED OR DEFECTIVE WHO WILL RETURN AND/OR EXCHANGE PARTS, ALL CONTRATORS, SUB CONTRATORS AND INSTALLERS MUST BE LICENSED BY THE CALIFORNIA STATE LICENSE BOARD. BOND AND WORKMAN'S COMP MUST BE UP TO DATE. GC TO LIST CLIENT AS ADDITIONAL INSURED AND SUPPLY COPY OF DOCUMENT. GC TO SUPPLY CLIENT WITH LABOR SCHEDULE BEFORE WORK COMMENCES. ALL SPECIALTY TRADES AND/OR RETAILERS TO SUPPLY CLIENT WITH ALL APPLICABLE WARRANTY INFORMATION.

### **UNFORSEEN CONDITIONS:**

SOME MECHANICAL OR STRUCTURAL ISSUES MAY BE CONCEALED AND WILL ONLY BECOME APPARENT AFTER DEMOLITION. SOME ITEMS MAY RESULT IN CHANGE ORDERS INCLUDE HVAC ROUTING. RANGE/COOKTOP VENTING AND FRAMING ISSUES THAT MUST BE BROUGHT UP TO CODE. HOMES BUILT PRIOR TO 1974 MAY REQUIRE ASBESTOS ABATEMENT. GC MUST TEST MATERIALS PRIOR TO DEMOLITION.

### WOOD FLOORING:




# PROPOSED KITCHEN FLOORPLAN PLUMBING AND ELECTRICAL CHASE DETAIL





# PROPOSED KITCHEN FLOORPLAN SECTION CUTS


