June 1

Deputy Kovic responded to a theft on County Road 2262. The victim advised she had a phone shipped to her house and noticed it was missing from the package it came in. The victim believed the phone company possibly did not put the phone into the box.

Deputy Williams responded to a dispute on County Road 1917. The caller advised a male was at her house who was violating a protection order. After the male was not located on scene, he was called and advised he was never at the property. No offense occurred

Deputy Hughes was dispatched to a terroristic threat in Holly Lake Ranch. Security officers on scene advised the suspect had made threats to them. Deputy Hughes was able to make contact with the individual who appeared to be intoxicated and resisted being detained. The security officer who was threatened advised he would like to press charges. Matthew Pfeiffer, 59, of Holly Lake Ranch, was arrested for terroristic threat and resisting arrest.

Deputy Williams responded to a theft call on County Road 1439. The victim advised his game camera showed copper wire stolen from his property and captured the vehicle that took it. The victim did not have any suspects but stated items had been stolen from his residence previously. This case will be forwarded to investigations.

Deputies responded to 1 animal call.

June 2

Deputy Kovic responded to a theft call on FM 778. The pastor of the church advised someone had stolen a historical marker from the church. The pastor stated he needed a report to get the sign replaced. This case will be forwarded to investigations.

Sgt Sepulvado was dispatched to a theft call in Holly Lake Ranch. The caller advised her firearm was missing out of her purse. The caller stated she has



had her gun fall out of her purse in the past and would like it reported missing in case it is located.

All animals in the residence had been vaccinated and were advised to be quarantined for 10 days.

Sgt Cox and Sgt Sepulvado performed a warrant service on Hwy 80. The wanted subject was located and taken into custody. While being patted down inside the jail narcotics were located on the individual. Jaco Jiles, 59, of Hawkins, Texas, was arrested for outstanding warrants and prohibited substance in a correctional facility.

Deputies responded to 1 animal call.

June 3

Deputy Baldwin responded to a disturbance on County Road 1895. The victim advised her and her boyfriend got into a dispute and he then grabbed her by the arms and pushed her into the wall multiple times. The victim advised the male subject also broke her cell phone during the argument. Dusty Rhodes, 23, of Emory, Texas, was arrested for assault and interfering with emergency call.

Deputy Hughes took a phone report of fraud. The caller advised someone called her and told her she needed protection for her Amazon account. The caller then made three purchases to the scammer. Her bank was able to reimburse her and she will cancel her account. This case will be forwarded to investigations.

Deputies responded to 3 animal calls and 1 transport.

June 4

Deputy Cooper performed a traffic stop on Hwy 154. Deputy Cooper observed the vehicle to not have a front license plate and began to catch up to the vehicle. Sgt Hanner noticed the vehicle, and observed it to be speeding. Upon Deputy Cooper making contact with the driver, he observed a marijuana grinder in the front seat. While searching the vehicle, a cigarette pack was located that contained crystal like substance. John Backus, 48, of Quitman, Texas, was arrested for possession of controlled substance.

Deputies responded to 1 animal call and 1 agency assist.

June 5

Deputy Rapp was dispatched to a disturbance at Lake Holbrook. Upon arrival, Deputy Rapp observed two males fighting and as he proceeded to



one of the males, he began to wrestle with Deputy Rapp. After the male was placed in handcuffs, he still proceeded to resist arrest and pull away. The suspect advised he had been drinking and became too intoxicated. Joshua Jeffcoat, 18, of Canton, Texas, was arrested for resisting arrest.

Deputy Pollard responded to a disturbance on County Road 1431. Deputy Pollard made contact with the individuals who advised they were arguing and no offense had occurred.

Deputy Cooper was dispatched to a shots fired in Holly Lake Ranch. Upon arrival, Deputy Cooper and multiple officers had to draw their rifles on the suspect due to him driving towards them and not stopping. After the suspect fled officers for ½ a mile, Deputy Cooper was able to pull the vehicle over. After the suspect was tased for not cooperating, he was successfully detained. Multiple firearms were located inside of the vehicle. Matthew Pfeiffer, 59, of Holly Lake Ranch, was arrested for Evading arrest, terroristic threat against peace officer, unlawful carry of a weapon, and resist arrest/transport.

Deputy Mayer performed a warrant service on Hwy 154. Smith County called and asked to check a residence for the wanted subject. Laurie Hinds, 61, of Quitman, Texas, was arrested for outstanding warrants.

Deputies responded to 4 animal calls and 1 agency assist.

Deputy Kovic took a phone report of criminal trespass. The caller advised she no longer wanted her ex-boyfriend at her property and would like him criminally trespassed. The ex-boyfriend was contacted and advised to not return to the property.

Deputy Hughes responded to a criminal mischief in Holiday Villages. The caller advised someone was driving a motorcycle through yards tearing up the grass. The suspect was located and advised to stop driving in people's yards.

June 8

Deputy Croney took a phone report of a suspicious person on County Road 3450. The caller stated his neighbor saw a truck stop in his driveway and a male get out and walk up into the caller's driveway. When the neighbor turned on a light, the male left in the vehicle. The caller will receive extra patrol.

Deputy Cooper initiated a traffic stop on Front St in Hawkins. Deputy Cooper did not observe a license plate on the vehicle and later observed it to fail to use a turning signal. While speaking with the passenger, Deputy Cooper observed them to be acting nervous and not making eye contact. Deputy Cooper was able to get consent to search all of the passengers and located a small bag with crystal substance in it. Charlene Cintron, 41, of Hawkins, Texas, was arrested for possession of a controlled substance.

June 9

Deputy Croney responded to an animal bite at the Qutiman ER. The victim advised one of her cats became scared and bit her while at her house. The victim was able to provide vaccine records for the cat and stated it would be quarantined.

Deputy Croney was dispatched to a criminal mischief on County Road 2302. The caller advised his daughters car had been keyed but he did not know when or where. The caller stated other incidents have occurred to his daughter but due to him having a lack of evidence he would just like the incident documented.

Deputy Pollard was dispatched to a burglary on Private Road 5551. Upon making contact with the individuals, Deputy Pollard observed them to be cleaners for the business. Laroyce McDaniel, 63, of Sulphur Springs, was arrested for an outstanding warrant.

Deputy Rapp took a phone report of a stolen firearm. The victim advised her ex-boyfriend had been at her house and the next day she noticed her firearm to be missing. The victim would like to pursue charges and this case will be forwarded to investigations.

Deputy Rapp responded to an accident on Loop 564. The fire Department advised the driver of the vehicle was possibly intoxicated due to her not being able to walk straight. As Deputy Rapp made contact with the driver, she admitted to being intoxicated. Ashlie Dailey, 29, of Mineola, Texas, was arrested for Driving While Intoxicated.

Deputy Croney responded to a disturbance on County Road 1570. Upon arrival, multiple females were found in a physical altercation. All of the parties' stories were not matching, a report will be filed and forwarded to investigations.

Deputy Rapp responded to a criminal trespass on Hwy 37. The parties both wanted to put a criminal trespass on each other. The parties agreed they would stay at the end of the driveway when dropping off kids so that they don't violate the order.

Deputies responded to 3 agency assists and 1 transport.

June 14

Deputy Whisenhunt was dispatched to a disturbance on County Road 4255. Upon arrival, the male subject advised his ex-girlfriend came over and they got into a physical argument. The male stated he would like to press charges against his ex-girl friend for the injuries he sustained. Deputy Whisenhunt was able to speak to the female suspect over the phone who stated she would like to press charges as well. This case will be forwarded to investigations.



Deputy Whisenhunt took a phone report of a theft. The caller advised his ex-wife stole gift cards from him while he was on the road working. The caller was advised to gather all information and call back once he is back home from work.

Deputy Rapp took a phone report of an identity theft. The caller believes someone has hacked all of her accounts and took money from them. The caller was able to freeze her accounts and will fill out an identity theft packet.

Deputies performed 2 transports.

The victim advised his friend they needed to leave and she then punched him in the face. The victim stated before they got home the suspect assaulted him again in the car. Neither party wanted to pursue charges and the parties were separated.

Deputy Croney performed a warrant service at adult probation. Thomas Walls, 31, of Mineola, Texas, was arrested for outstanding warrants.

Deputy Cooper initiated a traffic stop on FM 2869. Deputy Cooper observed a vehicle to be parked on the side of the road that had a blanket covering the front windshield. While speaking with the occupants, Deputy Cooper observed the passenger to be acting nervous and had dilated pupils. Deputy Cooper asked the passenger if she had any paraphernalia in the vehicle to which she showed him a smoking pipe. Deputy Cooper performed a probable cause search on the vehicle and located a bag containing crystal substance under the driver's seat. Frederick Williams, 46, of Hawkins, Texas, was arrested for possession of a controlled substance.

Deputies responded to 1 animal call and 1 agency assist.

June 18

Deputy Croney took a phone report of a dog bite. The caller advised while pulled over on the side of the road, he was bit by a stray dog and was able to scare the dog off. Deputy Croney was unable to



locate any dogs in the area, and the victim will get rabies prevention medicine.

Deputy Whisenhunt responded to a juvenile in the road in Yantis. Upon arrival, security in the area had already taken the juvenile back to their residence. Deputy Whisenhunt made contact with the juveniles' parents who advised he had slipped out the front door without them noticing. There is already an active CPS case with the parents and CPS was informed of the new case.

Deputy Croney responded to an animal cruelty on County Road 4560. The dog owner advised they have someone on camera "messing with their dog" and they later observed the dog to have a large cut on its leg. The dog owner will provide camera footage and this case will be investigated further.

The mother stated she was assaulted by her daughter, but there was no evidence of her being assaulted. Both parties were separated.

Deputy Cooper observed a vehicle to be passed the white line at an intersection and recognized the vehicle from a previous stop when it had a fictious license plate. Deputy Cooper observed the temporary tag on the vehicle to be the same numbers as the last tag that was confiscated. Leslie Alaman, 26, of Hawkins, Texas, was arrested for display fictious license plate.

Deputies responded to 1 animal call and 2 transports.



June 19

Deputy Whisenhunt responded to an animal complaint on FM 17. The caller advised he believed his neighbor had left dead calves near his driveway because he was mad at him. Deputy Whisenhunt was able to make contact with the cow owner who stated he did leave them there and that he would pick them up later. TXDot was notified to come and pick the animals up.

Sgt Hanner performed a pedestrian stop on County Road 4930. Sgt Hanner observed a male appearing to be in distress on the side of the road and made contact with him. The person advised someone was looking for him and he was scared and Sgt Hanner observed a smoking pipe beside his belongings. The driver then drove his vehicle several miles until he reached his residence and he fled on foot. Corporal Cooper was able to locate the individual and get him detained. Darrell Glosup, 54, of Quitman, Texas, was arrested for evading arrest.

Corporal Cooper responded to a disturbance on FM 2088. Upon arrival, Corporal Cooper located a vehicle that was abandoned but was unable to locate

the parties. Corporal Cooper met with a family member at their residence who stated the suspect was hiding and deputies were able to locate him. The female had multiple injuries to herself and denied anything physical had happened. Stephen Pyron, 31, of Winnsboro, Texas, was arrested for assault causes bodily injury.

Deputy Croney responded to a shots fired on FM 2869. The victim advised he was loading a firearm in his vehicle and as they hit a bump the fire arm went off and injured his leg. The victim was transported by EMS for injuries.

Deputy Pollard was dispatched to a pedestrian in the roadway on County Road 4860. As a trooper attempted to make contact with the suspect, she jumped into the lake and later ran from the trooper. CPS was contacted due to children at the residence. Kathryn O'Connor, 45, of Quitman, Texas, was arrested for assault family violence impeding breath.
