

**VILLAGE OF COHOCTON  
MONTHLY MEETING  
July 17, 2019**

The monthly meeting of the Cohocton Village Board of Trustees was held on Wednesday, July 17, 2019 at 7:00 pm, in the Village Office, 17 South Main Street, Cohocton.

Present were: Mayor, Janice Sahrle. Trustees: Sandra Azzi, Wendell Freelove, Kathryn Gray and Nate Martin. Also present were: Village Clerk-Treasurer Katherine Wise, Attorney for the Village Elizabeth Oklevitch, Code Enforcement Officer Chuck Cagle, Maintenance Supervisor Justin Coats, Fire Chief Bill Waggoner, Town Councilman Ron Towner, Rus Gray, Dave Pietrucha and Paul Sabins.

Mayor Sahrle called the meeting to order at 7:00 pm.

Justin Coats led the pledge to the flag.

**Minutes**

A motion was made by Trustee Martin, seconded by Trustee Azzi, to approve the June 19, 2019 meeting minutes as presented. The motion carried 5-0.

**Reports**

Code Enforcement Officer Chuck Cagle reviewed his monthly report with the Village Board.

The Board reviewed the Fire Department report.

Maintenance Supervisor Justin Coats gave the Board an oral Street and Water report and presented his letter of resignation.

The Board reviewed the Planning Board minutes.

A motion was made by Trustee Freelove, seconded by Trustee Azzi to approve the monthly reports as presented, approve the two fire department applications, and to allow the Village Attorney to send a letter to Northern Fire. The motion carried 5-0.

**Audit**

A motion was made by Trustee Azzi, seconded by Trustee Freelove authorizing the Clerk-Treasurer to pay the abstracts as audited:

Water Fund:	Vouchers 9-15 totaling \$6716.87

The motion carried 5-0.

A motion was made by Trustee Azzi, seconded by Trustee Freelove to approve the June 2019 books as presented. The motion carried 5-0.

### **Old Business**

There was no old business.

### **New Business**

A motion was made by Trustee Freelove, seconded by Trustee Gray to accept Justin Coats' resignation as Maintenance Supervisor effective July 19. The motion carried 5-0.

A motion was made by Trustee Freelove, seconded by Trustee Azzi to appoint Paul Sabins as Maintenance Supervisor at a rate of pay of \$18 per hour, with a six month probationary period. The motion carried 5-0.

A motion was made by Trustee Freelove, seconded by Trustee Martin to hire Andrew Sick as a full time Maintenance Worker at a rate of pay of \$13 per hour, to receive a dollar an hour raise once he receives his class c water license. He must also obtain his CDL. The motion carried 5-0.

A motion was made by Trustee Gray, seconded by Trustee Freelove to approve the Excellus dental plan number DBOC-4-26/26. The motion carried 5-0.

A motion was made by Trustee Freelove, seconded by Trustee Martin to remove Jean Cox as Deputy Clerk, per Civil Service regulations. The motion carried 5-0.

A motion was made by Trustee Gray, seconded by Trustee Martin to allow Andrew Sick to attend water training September 11 thru September 13. The motion carried 5-0.

### **Board Concerns**

Mayor Sahrle requested that the fire committee begin working on the Town and Village fire contract.

A motion to adjourn was made by Trustee Freelove, seconded by Trustee Azzi, the meeting was adjourned at 7:52 pm. The motion carried 4-0.
