Bloomfield Police Department Monthly Report for August 2018

This is the monthly report for the Month of August 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Wednesday, August 1st at approximately 10:15am officers received a theft complaint which occurred at Roller Rink Park/Beach located on S. Lakeshore Drive. It was reported that person(s) unknown had taken a wooden regulatory sign valued at approximately \$150.00 that had been permanently mounted at the park/beach. This incident remains under investigation.

On Saturday, August 4th at approximately 12:27am officers responded to the area of Hwy 12 and Bloomfield Road for a report of a vehicle operating in the wrong lanes of traffic. Officers located the vehicle and executed a traffic stop after observing the vehicle traveling eastbound in the westbound lanes of traffic. At the conclusion of the traffic stop a 60-year-old male was arrested and confined in the Walworth County Jail. The driver was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued traffic citations for operating wrong side of a divided Hwy and possession of open intoxicants in a motor vehicle.

On Saturday, August 4th at approximately 12:58pm officers responded to the area of Hwy 12 and Bloomfield Road for a single vehicle roll over injury crash. At the conclusion of the investigation a 46-year-old male was arrest for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued traffic citations for unreasonable and imprudent speed and possession of open intoxicants in a motor vehicle.

On Saturday, August 4th at approximately 3:07pm officers responded to the 1400 block of Daisy Drive for a disorderly subject complaint. At the conclusion of the investigation charges of disorderly conduct were forwarded to the Walworth County District Attorney's office for a 22-year-old female.

On Sunday, August 11th at approximately 1:24am officers made contact with a stopped motor vehicle on Hwy B at Lange Road. At the conclusion of the contact a 32-year-old male was arrested and confined in the Walworth County Jail. Charges of operating a motor vehicle while intoxicated 6th offense, operating a motor vehicle with a prohibited alcohol concentration, operating after revocation and tamper/failure to install an ignition interlock device have been forwarded to the Walworth County District Attorney's office.

On Monday, August 13th at approximately 1:50pm officers responded to Small Load Specialties, N1620 N. Daisy Drive for a theft complaint. It was reported that person(s) unknown had taken approximately a ¹/₄ yard of limestone without consent. This incident remains under investigation.

On Tuesday, August 14th at approximately 8:34pm officers responded to a burglary complaint at the Southern Stop located at N1083 Hwy U. It was reported that person(s) unknown entered onto the property and removed a table and a smoker without consent. This investigation remains under investigation.

On Thursday, August 23rd at approximately 1:39pm officers responded to the intersection of Hwy H and Hwy 120 for a personal injury traffic crash. This crash involved a vehicle which had moments earlier been involved in a vehicle pursuit west of Lake Geneva. A 20-year-old female driver was ultimately issued traffic citations for reckless driving endangering safety persons/property, unreasonable and imprudent speed, automobile following too closely and passing at an intersection.

On Sunday, August 26th at approximately 1:59am officers responded to the area of Hwy H and Litchfield Road for a single vehicle property damage only crash. At the conclusion of the investigation a 25-year-old male was arrested on confined in the Walworth County Jail. Charges of operating a motor vehicle while intoxicated 2nd offense and operating after revocation have been forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued a traffic citation for unreasonable and imprudent speed.

On Thursday, August 30th at approximately 6:09am officers responded to a burglary in progress at Spoon Doggers located at N1320 S. Lakeshore Drive. At the conclusion of the investigation the suspects were identified and Spoon Doggers declined prosecution. At the request of Spoon Doggers management the complaint was closed.

On Friday, August 31st at approximately 2:01am officers responded to a criminal damage to property complaint in the 1000 block of Golden Glow Road. The complainant reported that person(s) unknown had broken the windshield and damaged the paint of a vehicle parked at the residence. This incident remains under investigation.

During the month of August 2018, the Bloomfield Police Department responded to 895 calls for service compared to 948 calls for service during the month of August 2017. During the month of August 2018, the police department affected 140 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 111 arrests during the month of August 2017.
