Candie Bernard made a motion to hear Gary Fournier's recommendations, Beth Liller seconded the motion, all concurred.

- 1. DG Builders, 92 Oakmont Ln Stratton, VT (1602021.1) Current \$463,300 Assessor recommends reducing functional assessment 20% to \$380,400 due to 1 bedroom and overbuilt garage.
- 2. Becktold, 5 Plimpton Rd (1100053) Current assessment \$276,000, Assessor recommends reducing to \$251,200, adjusted quality and condition grade and corrected flooring information.
- 3. Pirie, Iain & Kristin, 75 East Birch Rd Unit 35 (0401006.35035) Current assessment \$275,800, Assessor recommends no change based on Vantage Point sales have all sold at or above new assessed values.
- 4. Lane Jacobs, Represented by Attorney Lance Shader, 589 Route 100 (1800013) Current assessment \$1394,500, Assessor recommends changing quality grade to A- and quality grade to very good from excellent due to age. New assessment \$1,077,900.

 line with comps in market area.
- Shanta Puchtler, 820 Mountain Rd Properties (Currently assessed 120010 \$155,100, 120026.100 \$231,100, 120026.200 \$1,785,00, 1200026.300 \$3,253,800 total \$5,425,000) No changes due to assessed value in line with assessor's value of market value.

9. Rocco Lettieri- 25 Acer Rd- (080028.300) Currently assessed at \$2,449,900, Assessor recommended no changes. Assessment according to exterior dimensions appear correct in assessing software.

10. Ross Powers Gold, Medal Circle (0800039.7) Current assessment \$195,700 Assessor recommends adjusting value to \$157,000 as land topography is steep lot and off drainage.

11. Skyfall Development LLC, 23 Gold Medal Circle (0800039.8) Current assessment \$2,133,300, Assessor recommends reducing value to \$2,112,700 with correction to update square footage.

Candie Bernard made a motion to accept all of the above decisions as stated. Beth Liller seconded the motion, all concurred.
