Public Bid Specifications

Pleasant Valley Road Culvert Projects

The Hocking Township Board of Trustees is seeking sealed bids for the replacement and installation of two (2) culverts on Pleasant Valley Road. All work must be completed in accordance with the following specifications:

Project Details

Location: Pleasant Valley Road, Hocking Township

Culvert #1

Pipe Size & Type: 18-inch diameter, double-walled smooth interior corrugated pipe

Length: 26 feet of culvert pipe

Scope of Work:

- Pavement must be cut to remove the existing culvert
- Contractor is responsible for removal and proper disposal of old culvert material
- Install new culvert as specified
- Backfill and restore pavement cut area

Materials Provided by Township:

- Culvert pipe furnished by the township
- 411 aggregate furnished by the township

Township Assistance:

- Two (2) township employees will assist with hauling aggregate and with the removal and installation of the culvert

Traffic Control:

- Township will close the road and furnish appropriate signage

Culvert #2

Pipe Size & Type: 18-inch diameter, double-walled smooth interior corrugated pipe, double insulated

Length: 35 feet of culvert pipe

Scope of Work:

- Pavement must be cut to remove the existing culvert
- Contractor shall furnish two (2) culvert pipes as specified
- Remove and dispose of existing culvert material

- Install new culvert as specified
- Backfill and restore pavement cut area if applicable

Materials Provided by Township:

- 411 aggregate furnished by the township

Township Assistance:

- Two (2) township employees will assist with hauling aggregate and with the removal and installation of the culvert

Traffic Control:

- Township will close the road and furnish appropriate signage

General Conditions

Completion Date: Both culverts must be installed and the project completed no later than August 1, 2025.

Bids:

- Sealed bids will be accepted until July 22, 2025 at 7:00 p.m.
- Bids will be publicly opened and read at the Hocking Township Board of Trustees regular meeting on July 22, 2025 at 7:00 p.m.

Additional Requirements:

- Contractor shall be responsible for compliance with all local, state, and federal regulations.
- Contractor must provide proof of insurance and any applicable licenses.
- Contractor must coordinate with the township road supervisor for scheduling and staging.
- Bid shall include all labor, equipment, and materials not otherwise specified as furnished by the township.
- Township employees will meet with each contractor prior to bid submission to answer questions and explain project details as needed to complete the bid package.
- A contractor packet including proof of liability insurance, workers' compensation coverage, and any required documentation must be completed and approved prior to starting the project.

The Hocking Township Board of Trustees reserves the right to accept or reject any and all bids and to waive any informalities.
