## ટી-૨૦ વર્લ્ડ કપનો પ્રથમ અપસેટ ક્રિસ્માબ્વેએ ઓસ્ટ્રેલિયાને હરાવ્યું



**(એવન્સી) કોલંબો,** ઓસ્ટ્રેલિયા અને ક્રિસ્માબ્વે વચ્ચે ટી-૨૦ વર્લ્ડ કપની ૧૯મી મેચ કોલંબો સ્ટેડિયમ ખાતે રમાઈ હતી. પ્રથમ બેટિંગ કરના, ક્રિસ્માબ્વેએ ૨૦ ઓવરમાં ૨ વિકેટ ગુમાવીને ૧૬૯ રન બનાવ્યા.

ક્રિસ્માબ્વેએ ટી-૨૦ વર્લ્ડ કપ ૨૦૨૬ ની ૧૯મી મેચમાં ઓસ્ટ્રેલિયાને હરાવીને મોટો અપસેટ સર્જ્યો. ૧૭૦ રનના લક્ષ્યનો પીછો કરતી ઓસ્ટ્રેલિયા ૧૪૬ રનમાં ઓલઆઉટ થઈ ગઈ. ઓપનિંગ જોડી જોશ ઈંગ્લિસ (૮) અને ટ્રેવિસ હેડ (૧૭) રન બનાવી આઉટ થયા, અને ત્રીજા નંબરે બેટિંગ કરી રહેલા કેમેરોન ગ્રીન પોતાનું ખાતું પણ ખોલી શક્યો નહીં. ક્રિસ્માબ્વેના બોલર બ્રેડ ઈવાન્સે શાનદાર બોલિંગ કરી અને ત્રણ વિકેટ લીધી.

ઓસ્ટ્રેલિયા તરફથી મેટ રેનશો (૬૫ રન) એ ક્રિકેટી ફટકારી. ગ્લેન મેક્સવેલે ૩૧ રન બનાવ્યા. માર્કસ સ્ટોઈનિસ (૬), ટ્રેવિસ હેડ (૧૭) અને જોશ ઈંગ્લિસ (૮) સારું પ્રદર્શન કરી શક્યા નહીં. ટિમ ડેવિડ અને કેમેરોન ગ્રીન પોતાનું ખાતું પણ ખોલી શક્યા નહીં.

ક્રિસ્માબ્વે તરફથી બ્રાયન બેનેટે ૫૬ બોલમાં અજાનમ ૬૪ રન બનાવ્યા. આ ટી-૨૦ વર્લ્ડ કપમાં તેની પહેલી અડધી સદી છે અને ટી-૨૦ આંતરરાષ્ટ્રીય મેચોમાં તેની કુલ ૧૧મી અડધી સદી છે. તેના સિવાય, તાદિવાનાશ મારુમાની અને રાયન બર્લે ૩૫-૩૫ રનની ઈનિંગ રમી. કેપ્ટન સિક્કર રજાએ ૧૩ બોલમાં અજાનમ ૨૫ રન બનાવ્યા. ઓસ્ટ્રેલિયા

તરફથી માર્કસ સ્ટોઈનિસ અને કેમેરોન ગ્રીને ૧-૧ વિકેટ લીધી. ટોસ હાર્યા બાદ પ્રથમ બેટિંગ કરવા ઉતરેલી ક્રિસ્માબ્વેની શરૂઆત સારી રહી. તાદિવાનાશ મારુમાની અને બ્રાયન બેનેટે પ્રથમ વિકેટ માટે ૬૧ રનની ભાગીદારી કરી. મારુમાની ૨૧ બોલમાં ૩૫ રન બનાવીને આઉટ થયો. તેમના આઉટ થયા પછી, રાયન બર્લે બેટિંગ કરવા આવીને તેમણે બ્રાયન બેનેટે બીજા વિકેટ માટે ૭૦ રન ઉમેર્યાં. બર્લે ૩૦ બોલમાં ૩૫ રન બનાવીને આઉટ થયો. તેમના આઉટ થયા પછી, બ્રાયન બેનેટે સુધી બેટિંગ કરી. બેનેટે ૫૬ બોલમાં અજાનમ ૬૪ રન બનાવ્યા, જેમાં સાત ચોગ્ગાનો સમાવેશ થાય છે. ત્યારબાદ સિક્કર રજા ૧૩ બોલમાં ૨૫ રન બનાવીને પેવેલિયન પરત ફર્યો. જેમાં બે ચોગ્ગા અને એક છગ્ગાનો સમાવેશ થાય છે.

As the country accelerates towards becoming a digitally empowered and globally competitive economy under the vision of Viksit Bharat, trust in communication has become a defining pillar of progress.

Truecaller's latest report shows that 1,189 crore of these unwanted calls were blocked before reaching users, helping millions avoid scams, wasted time, and unnecessary stress in an increasingly connected economy. With over 100

crore active phone connections in the country powering commerce, governance, and personal relationships, Truecaller today released its 2025 India Insights Report, offering a data-driven view of how spam and fraud are reshaping the nation's communication landscape and how technology is helping protect crores of people every day.

The report captures how these decisions played out across 2025, revealing both the scale of digital risk and the growing importance of protection. "In a country where connectivity is powering opportunity at every level, trust has become our most valuable digital asset," said Rishit Jhunjhunwala, CEO, Truecaller. ## New CPI series to make poverty estimates, policy responses more accurate: CEA Nageswaran

New Delhi, Feb 13 (IANS) As India launched the Consumer Price Index (CPI) series with 2024 as the base year, Chief Economic Advisor (CEA) V. Anantha Nageswaran has said the change better reflects household spending patterns, making poverty estimates more accurate, adding that the new findings reveal income growth and productivity gains.

The new CPI series found rising service consumption, as the share of food in domestic budgets declined and more accurate data will help fiscal and monetary policy makers formulate better responses to evolving economic conditions, Nageswaran said. CEA said the new series captures the transition in domestic budgets of food's share moving to services such as health, education, mobility and connectivity is typically associated with income growth and productivity gains.

All-India CPI inflation rate in January stood at

2.75 per cent (year-on-year), with rural price rise at 2.73 per cent and urban inflation at 2.77 per cent. Food inflation, in negative territory till December 2025 under the old series, stood at 2.1 per cent in the new series. "The monetary policy response in particular could become more focused on aggregate demand pressures rather than dealing with supply-induced inflation and dealing with it through a demand-sensitive variable like the interest rate," he said. Lower weightage for the otherwise volatile group of food and beverages may make the headline inflation less volatile, he noted. "If CPI volatility declines, it means that fiscal expenditure volatility such as Dearness Allowance (DA) fixation, inflation-indexed bonds, linked to CPI could also become more stable, predictable and reliable, and this could give better budget predictability and visibility as well to fiscal numbers," he further pointed out. The Min-

istry of Statistics and Programme Implementation (MoSPI) on Thursday released the first print of the revamped Consumer Price Index (CPI) series with base year 2024. The earlier six-group classification was replaced with 12 divisions to align with in-

ternational standards and uses the 'HCES 2023-24' for updating the household consumption basket. The new basket expanded to 358 items from 299, with goods rising to 308 and services to 50, underscoring the growing role of services in household con-

sumption. Saurabh Garg, Secretary, Ministry of Statistics and Programme Implementation, said the government plans to do base revisions of CPI every five years, with the next household consumer expenditure survey scheduled for 2027-28.

## Tech giant Apple to open its 6th store in India on Feb 26

New Delhi, Feb 13 (IANS) US tech giant Apple on Friday unveiled the barricade for Apple Borivali, its sixth store in India and second in Mumbai -- in a market which has seen the company's production and exports touching new highs.

According to the iPhone maker, the new store features the distinctive peacock-inspired visual identity first introduced at the September 2025 openings of Apple Hebbal in Bengaluru and Apple Koregaon Park in Pune, and more recently at Apple Noida.

The design signals confidence, detail, and a sense of arrival, seen through Apple's lens of creativity.

Apple Borivali will open for the public at 1 pm on February 26. "Apple Borivali will serve a growing community of startups and businesses -- offering a welcoming space where customers can explore Apple products, unlock creativity, and get

expert support from Apple's store team members," said the company.

At Apple Borivali, customers can explore and purchase Apple's latest product lineup, experience new features, and receive expert support from Specialists, Creatives, Geniuses, and dedicated Business teams.

According to Apple, customers can also take part in Today at Apple sessions - free, daily, in-store experiences, led by Apple Creatives, designed to help people learn, create, and get more out of their devices.

Meanwhile, Apple CEO Tim Cook said recently that the company set a quarterly revenue record during the October-December period in India. "We continued to gain momentum in emerging markets, which includes India, where we saw strong double-digit revenue growth," said Cook during the earnings call.

## Precious metals surge 1-2 pc over value buying at support levels

Mumbai, Feb 13 (IANS) Gold and silver prices surged on Friday as investors took to value buying after prices moderated due to huge declines in the previous session. MCX gold April futures gained 1.08 per cent to Rs 1,54,480 per 10 grams on an intra-day basis. Meanwhile, MCX silver March futures added 2.59 per cent to Rs 2,42,564 per kg. "Gold has recovered post the January end collapse and is well on its way to what we believe should be \$6,000 per ounce levels by CY26 end," said Sandip Ralchura, CEO of Retail Broking and Distribution and Director, PL Capital. "Gold has support at Rs 1,54,000 per 10 grams while silver on MCX has support at Rs 2,42,000 per kg," a market participant said. The broader uptrend remains intact, and the recent pullback appears to be healthy profit booking rather than structural weakness, market watchers said.
