A motion was made by Mike Harris to approve the financial reports with a second by Annie Jackson. The vote was unanimous and the motion was passed.

A motion was made by Curtis Hadnot to transfer \$6000.00 (from Library CD) to checking Waelder Public Library account with a second. The vote was unanimous and the motion was passed.
