Re: **BRINGING UNVACCINATED CHILDREN TO CHURCH**

As you all know, MKN SOP discourages unvaccinated children age 12 years and below to enter places of worship.

We find that younger children, especially those below 5 years old are unable to focus, cannot sit still, tend to move about and unable to wear their masks properly at all times, being young children.

As such, a decision has been taken by the Parish Response Team that in order to further safeguard the young, NO children below 5(five) years of age will be allowed to enter Church to attend Mass or any activity. This will take effect from 24<sup>th</sup> December 2021 and onwards as the number of those attending Masses will increase greatly.

The consent forms which parents / legal guardians have signed earlier for those 12 years and below will deem applicable for children age 5 years and above effective 24<sup>th</sup> December 2021. This means you do not need to resubmit new forms for your children age 5 to 12 years old.

A reminder that those who have not submitted any consent form but wish to bring their children age 5 to 12 years, to please fill up the form (pto) and submit to parish office latest by Wednesday 22 December 2021.

Please note that all children must be accompanied by fully vaccinated parent(s) / legal guardian(s) and be listed as dependents in their parents/guardians' MySejahtera App.

Let us unite and be vigilant for the safety of all.
