YOU MAY REMEMBER HEARING SOME OF THE ANNOUNCEMENTS WE WERE REQUIRED TO AIR REGARDING OUR BROADCAST LICENSES. ALL OF OUR LICENSES WERE SET TO EXPIRE THIS YEAR. BUT, THANKS TO THE HARD WORK OF OUR CHIEF ENGINEER, I AM HAPPY TO REPORT THAT ALL OF OUR FCC LICENSES HAVE BEEN RENEWED FOR ANOTHER 8 YEARS; UNTIL THE YEAR 2028. WE PRAISE THE LORD FOR THE TOOLS HE HAS BLESSED US WITH TO COMMUNICATE THE GOSPEL MESSAGE TO NORTHEAST WISCONSIN AND SOUTH CENTRAL UPPER MICHIGAN.

THESE LICENSES SHOULD NOT BE TAKEN FOR GRANTED. THERE ARE MANY THINGS THAT WE HAVE TO DO BEHIND THE SCENES TO SATISFY ALL OF THE REQUIREMENTS OF HOLDING THESE LICENSES. THERE ARE MANY TECHNICAL REQUIREMENTS AS WELL AS PROGRAMMING REQUIREMENTS WE HAVE TO MEET EACH DAY. OUR EXPERIENCED STAFF, MADE POSSIBLE BY YOUR CONTRIBUTIONS, WORK EACH DAY TO MAKE SURE THESE REQUIREMENTS ARE MET.
