Scope of Work:

The Town of Clifton has been awarded a federal Community Development Block Grant from the State of Arizona Department of Housing (ADOH) and will accept bids from qualified firms or individuals with a minimum of a B-2 commercial license as registered with the Arizona Registrar of Contractors to perform the following services: Provide accessible route to the 2nd floor of the Town of Clifton's Community Center. The improvement shall comply with the 2010 ADA. Contractor shall provide, but not be limited to, the following scope of work to remodel the pertaining space:

- ADA compliant concrete ramp and landing
- Door, door hardware and threshold modification
- 14" deep concrete Pit at the elevator
- Elevator shaft (not fire-rated)
- LULA elevator (Wheelchair Lift) and necessary auxiliary equipment
- HVAC – ductless mini-split & existing duct modifications
- Power to the LULA elevator
