**Your experience is an investment in teamwork, inclusion, and employee health:**

- For a nominal rental fee for each practice of \$175 for 60 minutes of on-water experience with a coach / stern your team will have a great time.
- Our experience tells us that many Corporate Rentals find they want to continue the teambuilding activity for more than one or two practice sessions. To help you with your investment, when your team books four or more practices a discount is applied and the fee is \$150 per practice!
- We know sometimes things develop that prevent your team from practicing when scheduled. In fairness to all the organizations using our equipment and to our Coaches/Sterns please give us a minimum of twenty-four-hour cancellation notice. If you are unable to provide advance notice your team will be charged \$175 (or equal to your practice fee).

**GCDBC looks forward to your Corporate / Rental Team learning our sport:**

We want you and your team to enjoy yourselves, so we want you to be successful which means your team must have a coordinator who will be responsible for:

- Collecting fees from each member and submitting one payment to the club by check, cashier's check or money order. No cash payments please. Checks made payable to GCDBC. Our insurance requires payment must be submitted prior to paddlers getting in the boat.
- All participants completing and signing a waiver prior to practice. Coordinator must make sure waivers are legible. Otherwise a separate list of names must be submitted to the club in compliance with the club insurance.
- Being prompt. Practices must start and end on time. Make sure that team activity such as team warm up, fee collection does not delay start of practice. If your team starts late – a full practice may not be guaranteed.
- Participants will be expected to assist the club in prepping the boat for practice, clean up and putting it away after session.

**GCDBC will provide Corporate / Rental teams:**

- Provide all necessary equipment such as the boat, life vests, paddles and a steersman.
- Provide safety instruction prior to each practice.
- Provide a one hour long practice and coaching.
- Provide basic paddling instruction on land to new paddlers (teams are expected to build extra time for this, in order not to consume on water practice time).
- Provide a rental coordinator to respond to team communications/concerns/scheduling.
- Provide the waivers to be completed by paddlers.
- Start and end practice on time.

GCDBC is not responsible for providing storage for personal property such as cell phones, car/house keys, purses, backpacks, etc.
