From the Airport Manager...



Finally, some rain! Hopefully we can build up the ponds and get some much needed precipitation this winter, and that it doesn't all come in snow and ice.

I have been applying for as many grant applications as possible, and trying to take as many opportunities to attend conferences and trainings so


keep in front of the FAA, so that they don't forget about Garnett, and the needs of our airport. It is always harder to receive monies dispersed when you are a small airport. They don't receive near the attention of projects at larger airports such as Topeka or Lawrence, but they are just as important! I have applied for several grants through the Kansas Department of Aviation and KDOT that deal with refurbishing some of the facilities located at the airport. The windows of the airport office were installed in the 1950's and could use some updating. When the manifold cracked on the old shop heater in the office we were able to use one hundred percent FAA grant to update to a newer mini split A/C and heater. That has been wonderful to have!

As I write this article, I have received good newsthe Garnett Industrial Airport was chosen to receive an additional \$145,000 from the BIL Bill to be used for updating the airport. This is in addition to the \$110,000 that we received last year from the BIL Bill and the \$300,000 that is available for use with the runway project. The Airport Advisory Board voted to approve buying an advisory AWOS (Automated Weather Observation System) for the airport. The late Gary Ecclefield was able to keep the prior system working for many years after it was outdated. Unfortunately, mice, and weather took a toll on the machine. Also, the old Vista operating system and I486 computer finally failed, and we are looking at several lower cost systems to replace it.

The City, the Garnett Airport Advisory Board, and I have finished and submitted the Environmental Assessment Study required by the FAA to the FAA. These are always required before any large project with the federal government can ever get started. There were no findings that adversely affected the runway project. We have gotten our consulting engineer selected, and are moving on to the next phase of the runway project. As far as events and projects for the upcoming year, we plan on continuing to host the Egg Drop/Hunt event, and are on track to do the Annual Air Fair Event in conjunction with the BPW Square Fair. The Fall Fly-in event was also such a success that we plan on trying to host that event several times this coming year. As we enter into the challenges and rewards of a new year, I hope we can continue to grow and improve the Garnett Industrial Airport to help the area attract new businesses and residents. Also, if you would like more information about flying, or other aviation opportunities, please come out and talk with me.



From Public Works...



There has been a lot progress in Garnett's Public Works' departments this summer and more to continue this fall. Many tasks and accomplishments being taken on by public works staff have not been completed in some time and they are proving Garnett has the ca-

pability to take care of itself.

At the Garnett Water Treatment Plant Jeff Mucklow obtained his Class IV Water Treatment License, and Zach Smothers his Class II Water treatment License. Jeff is now the 3rd operator on staff with a Class IV license, which I'm told is a first for the City of Garnett. This is testament to the culture being created there.

The water plant also completed their lead and copper sampling and testing for 2022. These results will be included in the 2022 Consumer Confidence Report. Superintendent James Howard would like to thank all the citizens that participated and assisted with this sampling. They also completed their annual burnout throughout the month of October.

The city's contracted engineering firm, P.E.C. is hammering out the final verbiage with K.D.H.E. on the new water plant. As soon as that's complete, P.E.C. will start putting the project out to bid.

The Garnett Wastewater plant has continued replacement of major components reaching their 20year life span. They also replaced sewer main along the 100 and 200 block of North Olive.

The Garnett Gas Department upgraded and replaced an old unprotected steel gas main to a P.E. gas main from the 600 to 900 block of West 4th. They have another major line replacement planned for North Oak Street early this Fall. The department also replaced an old cast water main on the 400 block of North Cedar. 300 feet of waterline and a high rise was installed at the south shop to improve salt brine mixing for the coming winter. The Garnett Gas Department is continuing to improve its training. Along with quarterly breakout sessions, the entire department attended hands on O.Q. training at the KMU facility in McPherson on August 31st and September 1st.

The refuse department has been completing the new trash route for a few months now. There have been several "hick-ups" mainly due to repeated mechanical failures. I apologize for these inconveniences as they can be very frustrating. But help is on the way! Manager Wilson and the City Commission have approved the purchase of a new Freightliner trash truck with a Cobra compactor.

There is a lot going on in the Garnett Street Department as well. They have reworked the ground south of Crystal Lake in preparation of park construction. A small section of East Monroe had a complete rebuild in front of Parkside Place. 50 ft of curb was replaced on Maple and 1000 ft of curb on North Elm will be replaced by the time of this printing. Lazy guttering has been replaced on North Cedar. The majority of Elm Street and West 3rd Street was resurfaced with blacktop. Base and substructure was re-built in many of these areas.

As the number of staff, equipment, and dollars are limited, outside of the norm projects can be difficult to complete. But these public works departments and staff members do a fantastic job of working together and are completing infrastructure projects that many towns of similar size can't. That I am proud of.

Lastly, infrastructure projects often put a wrinkle in the daily routine of citizens. Whether a road is closed on your way to work, the water is off when you need to start a load of laundry, or the gas is off when it's time to cook lunch, it can be very frustrating. We will always attempt to give as much notice as possible.

Thank-you Garnett citizens for your patience.

A Message from Code Enforcement and Animal Control

Pet Registration Due - 2023 Registrations will be due soon!

This is just a reminder that your pet's vaccination expires Owners of dogs and cats within the City of Garnett are required to purchase pet licenses annually at City Hall.

Between January 1 and before March 1, the city will collect a registration fee of \$7.50 for spayed or neutered dogs and cats, and \$20 for any dog or cat that is not spayed or neutered.

As of March 1, 2021, the fees will double to \$15 and \$40 respectively. Replacement tag fee for lost tags are \$5.

Please note: Certificate of current rabies vaccination provided to you by your veterinarian, along with verification of spaying or neutering, is required at time of City pet license purchase.

Thereafter, by ordinance a notification will be sent to a pet owner 30 days in advance of the expiration of their pet's rabies vaccination. Owners will be required to provide the new rabies vaccination information to the city within 30 days of notification. Failure to comply will result in the pet license being revoked and a fine issued.

Cold Weather Care for Animals - Make sure your animals, if outside, have shelter from the cold and access to food and water when temperatures drop below 40 degrees.

Animal Pick-Up Fees - If your animal is picked up and taken to Countryside Veterinary Clinic, you as the owner, are responsible for all fees incurred before the animal will be released. Please keep your pets inside or kenneled.

From the Zoning Administrator...



Good things are coming to Garnett! The City of Garnett received a C-CLIP grant this year to make storm-

water and roadway improvements on Maple Street/US-59. Work will begin between early March and mid-May, and will last about 90 days. During the project, the stormwater system will

receive improvements including additional inlets, and larger pipe underground. Once the work on the stormwater system has been completed, Maple Street will be resurfaced between 4th Avenue and Redbud Ln. While construction is taking place, traffic will still be moving in both directions, but not all three lanes will be available. During this project, please pay attention to the construction signage, and follow the traffic management plan. Also be mindful of those working on the project, as they work to make things safter for us.

We also have some other construction happening in town, as I am sure by now you are aware. Leizsler Oil is building a new Short Stop convenience store on the southeast corner of Park Road and Maple Street, the former site of Ron Ratliff's Anderson County Sales. And to settle the rumors, Papa John's will be located inside.

On the north side of Park Road, where the old cheese plant used to be, we will see another new business, a Dollar Tree/Family Dollar store. This project has been in the works for some time, and I am glad that it is happening. The Family Dollar corporation will take possession of the building from its owner on January 2, 2023. Both Businesses expect to open around March 1, 2023.

Additionally, Countryside Veterinary Clinic is expanding! Construction started mid-December on a new clinic building, just to the north of the larger animal clinic. Ed Moor Construction of Gardner is the general contractor, and the Allisons are excited for their new facility, so they can elevate the excellent level of service they currently provide for our community. There is no word yet as to when construction will be complete.

Many may know that I came to Garnett with a history of Downtown Revitalization. I worked in two communities and consulted in numerous communities over a 30+ year span. The Main Street program is one that produces many results and consistently is very successful. ACDA decided two years ago that Downtown Revitalization is very important to economic growth and development for Anderson County We launched three public meetings in 2021 and began working to form a Main Street/Downtown Revitalization program. We held a Main Street 101 orien-* tation and then we formed and Advisory Board and they began working. They worked together to name the program the Garnett Downtown Square Revitali-The logo is pictured below. They created zation. boundaries for the program which are 3rd Avenue to Please heed these tips: 6th Avenue and Walnut to Main Street. The groundwork has been laid for a successful program. From the Fire Chief...



As we enter 2023, here are some of our annual reminders:

Are your home address numbers * visible from the street and easy to see at night? Can emergency vehicles find your home easily? Now is a great time to look, and if necessary, take the steps to improve visibility.

Are your smoke detectors and carbon monoxide detectors working? Heating the home is the second leading cause of house fires. As the temperature goes down the risk goes up.

Carbon monoxide is an invisible, odorless, colorless gas created when fuels (such as gasoline, wood, coal, natural gas, propane, oil, and methane) burn incompletely. In the home, heating and cooking equipment that burn fuel can be sources of carbon monoxide.

- Never warm up a vehicle in the garage even with the door open. Have fuel-burning heating equipment and chimneys inspected by a professional every year before cold weather sets in.
- When using a fireplace, open the flue for adequate ventilation. Never use your oven to heat your home.
- Remember to turn portable heaters off when leaving the room or going to bed.
- Keep anything that can burn at least threefeet away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- Did you know that closing your doors in your home is also important for your safety? Closed doors can reduce fire growth, limit damage to your home, keep temperatures down, and can even save your life if you become trapped. A fire needs oxygen to burn. A closed door keeps more oxygen in the room and away from the fire. When you exit a fire, make sure to close your door
- behind you to slow down its growth. Learn more at closeyourdoor.org.

CodeRed Emergency Notification

CodeRed delivers warnings/alerts to you by telephone. Sign-up online through the link on our website.

This system identifies persons who have signed up for this service who are in the path of a tornado, severe thunderstorm or flooding. Additionally, evacuation notices, missing persons and other emergency information can create an alert to your phone.

Storm Shelter Information

The Emergency Information link on our website provides a complete list of storm shelters throughout Anderson County. There are two (2) current active shelters in Garnett:

In the event of a weather warning these shelters will be open and available to the public.

Text-to-911

Texting 911 can be done by typing "911" in the field for a phone number on your wireless phone.

Situations when Text-to-911 is appropriate:

- * Deaf, hard of hearing callers, or individuals with a speech disability;
- * A caller who is unable to speak due to a medical or other condition
- * Emergency situations that would put the caller in danger if making a voice call
- * Examples include abduction, domestic violence, or active

shooter situation.

In the event you cannot safely make a voice call to 911 in an emergency, you can text to 911. This is a project between Anderson County Emergency Communications and Kansas 911 Coordinating Council.

Remember, the best way to contact 911 is by making a voice call. *Please only use this service in an emergency when a voice call is not possible or safe.* Please note that Text-to-911 may not be available outside of Anderson County.
