**August Approvals:** 1923 Stonesgate- landscape; 1103 Stonehead- replace garage doors, front doors and add a gate on side of the house; 1656/1662 Hawksway- remove two pine trees; 1109 Stoneshead- replace patio doors; 1158 Galesmoore- add artificial grass, pavers and patio cover.

**Denials:** August- 1181 Kelsford- adding elevation and columns- need updated plans to review.
