Admissions and Referrals

The AARF serves substance involved adults who need this level of care to manage substance withdrawal symptoms and/or enter into continued treatment services.

Direct Referrals

Direct referrals are accepted from self-referrals, physicians, law enforcement, court officials, and other community agencies.

The 24 hour Call-Center provides preliminary referrals & scheduled appointments for individuals seeking services.

Admission Types

Voluntary

Involuntary

Length of Stay

Length of stay is usually 3 to 5 days. Individuals may stay longer on a voluntary basis awaiting placement, only when coordinated by the Case Staffing Team. The facility is open 24 hours a day, 7 days a week.

Discharge Planning

Plans for continuing care begin at the time of admission. Prior to discharge, recommendations are made in conference with the person served based on individual needs and treatment preferences.

Individual Responsibilities

Provide necessary admission items and participation as follows:

- Picture ID
- Healthcare/Insurance Information
- Prescribed medication in labeled pharmacy containers
- Participation in ongoing assessment processes
- Participation in group curriculum
- Payment for assessment/intake

Financial Information

ACTS is a private, non-profit organization. Fees for services are \$230.00 per day; however, reductions and/or waivers are established on a sliding scale basis. We do not refuse services to anyone based on their inability to pay. ***Persons served can have no more than \$20 at any time within his/her possession while in the facility.**
