AN ORDINANCE AUTHORIZING PURCHASE OF AMBULANCE AND BORROWING FUNDS FROM CHAPIN STATE BANK

WHEREAS, 65 ILCS 5/11-5-7 and 65 ILCS 5/11-5-7.2 authorize the Village of Chapin to provide emergency medical services and ambulance services to Village residents and to non-residents;

WHEREAS, pursuant to Village Ordinances 2006-4 and 2010- ____ the Chapin Area Rescue Squad provides Basic Life Support Transport (BLS) and ambulance transport to residents and non-residents;

WHEREAS, the corporate authorities of the Village of Village of Chapin, Illinois, deem it necessary and advisable to purchase and maintain a second ambulance to be used by the Chapin Area Rescue Squad;

WHEREAS, the corporate authorities of the Village of Chapin, Illinois, deem it advisable and necessary for the health, safety, and welfare of the residents of the Village of Chapin, Illinois to purchase from American Response Vehicles a used ambulance described as follows: a 2007 Ford #450 van for the sum of \$27,500.00;

WHEREAS, on July 14, 2010, the corporate authorities of the Village of Chapin, Illinois, approved by roll call vote the purchase of the aforementioned ambulance and the borrowing of funds to defray the costs of said acquisition;

WHEREAS, the corporate authorities of the Village of Chapin, Illinois, deem it necessary and in the best interests of the Village of Chapin to defray the costs of purchasing the ambulance by borrowing the principal sum of \$25,500.00 from Chapin State Bank, Chapin Illinois, subject to the repayment terms and conditions set forth in a certain

promissory note, a copy of which, marked as Appendix A, is attached hereto and incorporated herein by this reference; and

WHEREAS, pursuant to 65 ILCS 5/8-1-3.1 the Village of Chapin has the authority to borrow money from Chapin State Bank;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The foregoing recitals and findings are incorporated herein as if they had been restated verbatim.

SECTION 2: It is advisable, necessary, and in the best interests of public health, safety, and welfare that the Village of Chapin, Morgan County, Illinois, purchase the above-described ambulance from American Response Vehicles for the sum of \$27,500.00; therefore, the purchase of said ambulance is approved.

SECTION 3: It is advisable and necessary for the Village of Chapin to borrow the principal sum of \$25,500.00 from Chapin State Bank to defray the costs of purchasing the ambulance; therefore, the borrowing of the principal sum of \$25,500.00 from Chapin State Bank, under the terms and conditions set forth in the attached Appendix A, is approved.

SECTION 4: The Village President, Bryce McCormick, and the Village Treasurer, Wendy Bridgewater, are hereby directed and authorized to execute all necessary documents to effectuate and complete the purchase of the ambulance and the borrowing of money from Chapin State Bank. The form of promissory note, attached hereto as Appendix A, is approved and accepted. Both the Village President and the Village

Treasurer shall execute all documents necessary to obtain the above-referenced financing.

SECTION 5: The July 14, 2010 roll call vote of the corporate authorizes approving the purchase of the ambulance and the borrowing of funds to purchase the vehicle is ratified and affirmed.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
