Old Fort Days Barrel Futurity - 2021 Nomination

The Old Fort Days (OFD) Futurity is open to all foals of **2017** and later. To enter, the horse must <u>never</u> have competed in barrels (including registered shows, open shows, jackpots, rodeos, play days, showdeos, futurities, etc.) before **November 15, 2020**.

The **NOMINATION** deadline is December 1st (2nd- 10th, **2020** grace period). Late nominations are accepted (those entries received after December 10th), as long as an additional fee of \$200 per entry is paid and accompanied with a \$100 late fee for each missed payment. All nominations must include a copy of the horse's registration papers, regardless of who is listed as the owner. Grade horses are eligible to enter, as long as, registration papers from a credentialed registry are provided. *Important: Nominations received after December 10th that do not include the appropriate late fee(s) and/or do not include a copy of the horse's registration papers will not be considered official entries.* Owner changes will be updated by submitting a copy of the registration papers reflecting new ownership. When submitting an owner change, please provide the complete mailing address, phone number and e-mail address. During the actual event, it is important for ownership information to be current and accurate for tax and payout purposes. Payout checks are issued to the owner listed on the horse's papers.

SUBSEQUENT PAYMENTS are due on the 1st day of each month. A late fee of \$100 will be assessed for each payment received after the 10th day of each month, with the exception of the final payment in April. There is no late fee option for April's payment. All outstanding payments and late fees must be received in the office no later than April 10th. Entries not fully paid by April 10th will be considered ineligible to compete and all prior payments and fees will be forfeited. (Exception: If you pay your horse in full, in advance and have to drop your entry, any payments made that are not yet due from the date we are notified will be refunded).

HORSE SUBSTITUTIONS permitted. A nominated entry can be substituted with another horse, as long as; both horses have the same owner. A completed Substitution Form, registration papers and a \$500 substitution fee must be paid and received in the OFD office prior to April 10th.

By completing and mailing the official nomination form below, you are agreeing to abide by the above listed stipulations and all OFD rules and conditions. Any disputes or questions will be decided by the Chairman and will be considered final. If you have any questions, please don't hesitate to contact us at 479-783-6176, ext. 211. Event updates can be accessed either by the OFD web page and/or Facebook page.

Page two contains a schedule for all subsequent payments. There will be a \$50 charge on any insufficient or returned checks. All credit/debit card transactions will incur a 5% convenience fee.
