Meet the Home Inspector Requirements!

The Home inspector profession has become regulated in Florida since July 1, 2010. The requirements for initial licensure under the current law are: passing an examination, completion of a 120-hour course of study that covers a home's structure, electrical system, HVAC system, roof covering, plumbing system, interior components, exterior components, and site conditions that affect the structure, and proof of good moral character.

House Bill 713 also requires the following:

- The applicant may take the examination before applying for a license
- The applicant must submit to a criminal background check
