## ACKNOWLEDGMENT OF RISK, WAIVER OF LIABILITY, AND INDEMNIFICATION AGREEMENT:

This includes the use of the playground structures. As the parent or legal guardian of the above named child(ren), I hereby agree to individually protect for the possible future medical expenses which may be incurred by my child as a result of an injury sustained while participating in any program of instruction, recreation or competition at, for, or under the direction of Lakeshore Dance & Gymnastics INC.
