

**RESORT VILLAGE OF BIG SHELL
BYLAW 2-2023**

A bylaw of the Resort Village of Big Shell to amend Bylaw No. 2-85 the Resort Village of Big Shell Basic Planning Statement.

The Council of the Resort Village of Big Shell in the Province of Saskatchewan hereby amends Bylaw No. 2-85 as follows:

1. Schedule "A" to Bylaw No. 2-85, is amended as follows:

1.1 by adding a new subsection to Section 3 as follows:

"3.5 In order to aid prevention of the use of Municipal Reserves and other public recreational lands for storage of private goods, council may designate and develop areas specifically designed for storage uses. Such area will be located in Area "A" and will be zoned to a special district."

1.2 by adding a new clause to Section 4.1 as follows:

"f) ST – Storage District

To provide for secure storage of vehicles and chattels of residents of the village, in areas where such use will not conflict with the environmental and recreational quality of village park lands."

1.3 by amending the boundary of the Resort Village of Big Shell as shown on Map No. 1 Existing Land Use and Map No. 2 Future Land Use to include Parcel A, Plan 101809953 and Parcel B, Plan 102024638, lying within the South East quarter of Section 5, Township 49, Range 08, West of the Third Meridian..

2. That this Bylaw take effect upon the date it is approved by the Minister of Government Relations.

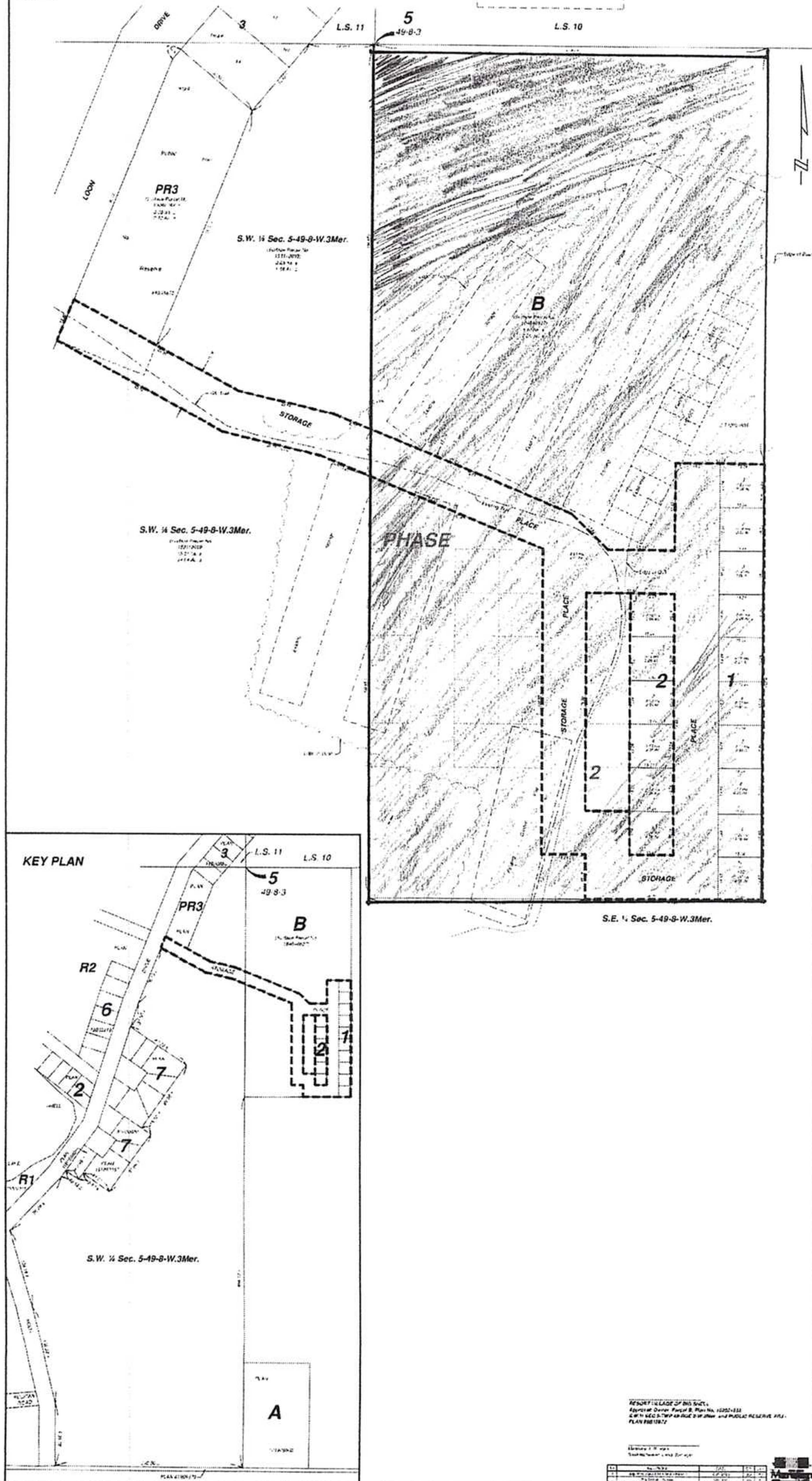

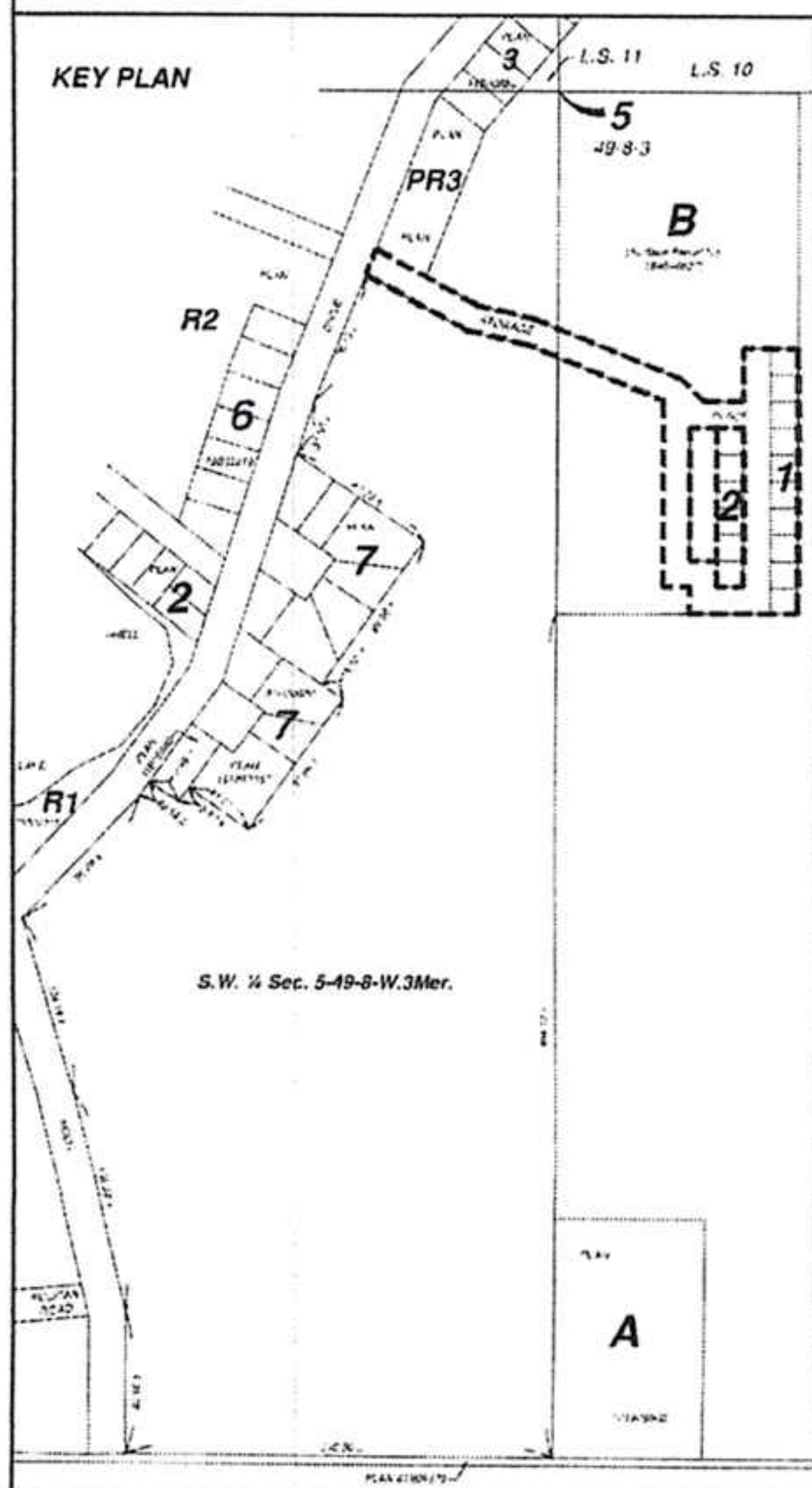
PLAN OF PROPOSED SUBDIVISION
