## AN ORDINANCE AMENDING THE SEWER RATES FOR THE VILLAGE OF STRASBURG, SHELBY COUNTY, ILLINOIS.

WHEREAS, the Village of Strasburg is authorized pursuant to 65 ILCS 5/11-129-1 *et. seq.* and 65 ILCS 5/11-139-1 *et. seq.* to establish reasonable rules, regulations and rates for its water and sewer utilities; and,

WHEREAS, the Board of Trustees of the Village of Strasburg, after careful investigation, have determined that it is necessary to amend the rate for sewer service of resident customers of the Village of Strasburg, Shelby County, Illinois; and,

WHEREAS, after due deliberation and consideration, it has been determined to be in the best interest of the Village of Strasburg and the health and safety of its residents that the sewer rates shall be amended in a manner set forth below.

# NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STRASBURG, SHELBY COUNTY, ILLINOIS, AS FOLLOWS:

- **SECTION 1.** <u>SEWER SYSTEM</u>: The following amended rates are hereby established for sewer usage for the resident sewer customers of the Village of Strasburg sewer system, provided said customer also has a water meter:
  - A. Minimum charge for the first two thousand (2,000) gallons of water consumed: \$23.00. Said rate is to increase to \$24.00 on August 1, 2020 and to \$25.00 on August 1, 2021.
  - B. Amounts consumed in excess of two thousand (2,000) gallons of water shall be \$.20 per one hundred (100) gallons consumed.
  - C. All customers that only receive sewer, with no water meter, shall be charged a flat rate of \$28.00.
  - D. That the rates identified hereinabove shall become effective on August 1, 2019.
- **SECTION 2. SEVERABILITY**: If any section, subsection, sentence, clause, phrase or portion of the ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed to be a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.
- **SECTION 3. REPEAL**: All ordinances or portions of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 4.** <u>PUBLICATION</u>: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication by the Village Clerk in pamphlet form as provided by law.
