RESOLUTION NO: SL – 04 - 2021

TITLE: Approval of IHBG – CARES Act Policy

WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statute 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

WHEREAS, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and

WHEREAS, in the early part of 2020, multiple cases of the Coronavirus (COVID-19) appeared throughout the United States causing the State of Nevada and many other states to declare a state of emergency which included a mandatory stay at home order in place for all persons excluding essential workers. The Coronavirus was declared a National Pandemic; and,

WHEREAS, in an effort to aid tribal members the 2020 Indian Housing Plan (IHP) CARES ACT states the Summit Lake Tribe will provide tribal members with Utility Assistance, Hotel Room Assistance, Grocery Assistance and provide members with Personal Protective Equipment (PPE); and

WHEREAS, The Tribal Council proposes the following Summit Lake Paiute Tribe's IHBG – CARES Act Policy, to enable the tribe to meet the Indian Housing Block Grant (IHBG) requirements; and

WHEREAS, the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe, to adopt IHBG – CARES Act Policy in an effort to aid tribal members with utility assistance in the amount of \$400.00, grocery assistance in the amount of \$200.00 and hotel room assistance to help prevent the spread of COVID-19 and to provide all tribal members with PPE; and

NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada hereby approves the adoption of the Summit Lake Paiute Tribe's IHBG – CARES Act Policy.
