Pre-Paid Standard Direct Cremation Packages Range \$1155 - \$1335

If you want to arrange for a direct cremation, you can use an unfinished wood box or an alternative container. Alternative containers may be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is \$130 and is included in all packages and listed below as an Alternative Container.

*****Standard Direct Cremation Package with Nationwide Shipping / Handling Included (Pre-Paid Plan):**

Basic professional services, securing a doctor signature via EDRS, notification of Social Security, transportation or receiving deceased from place of death or holding facility (35 mile radius), refrigeration care (up to 10 days), basic cremation fee for the act of the cremation process for an individual up to 275 lbs., the filing of required documents for a direct cremation service, cremation approval (up to \$50 included), two death certificates, retrieval or receiving of death certificates from a county office, , priority U.S. Mailing of death certificates, with the return of the cremated remains to the authorized individual via USPS Express Shipping (handling included). A standard temporary urn and a fiberboard box is provided. Removal of pacemaker is included, if needed. A 3.5% convenience fee is included in the cost as a cash advance item.

*****Standard Direct Cremation Package with Sea Scattering Included (Pre-Paid Plan):**

Basic professional services, securing a doctor signature via EDRS, notification of Social Security, transportation or receiving deceased from place of death or holding facility (35 mile radius), refrigeration care (up to 10 days), basic cremation fee for the act of the cremation process for an individual up to 275 lbs., the filing of required documents for a direct cremation service, cremation approval (up to \$50 included), retrieval or receiving of death certificates from a county office, two death certificates, U.S. Priority Mailing of death certificates, a temporary plastic urn contained in a fiberboard box and unattended sea scattering of the cremated remains in the Atlantic Ocean with GPS Coordinates Certificate. Removal of pacemaker is included if needed. A 3.5% convenience fee is included in the cost as a cash advance item.

*****Standard Direct Cremation Package (Pre-Paid Plan):**

Basic professional services, securing a doctor signature via EDRS, notification of Social Security, transportation or receiving deceased from place of death or holding facility (35 mile radius), refrigeration care (up to 10 days), basic cremation fee for the act of the cremation process for an individual up to 275 lbs., the filing of required documents for a direct cremation service, cremation approval (up to \$50 included), retrieval or receiving of death certificates from a county office, two death certificates and a post cremation conference at our office for the return of the cremated remains to the authorized individual by appointment in a temporary urn within a fiberboard box. Removal of pacemaker is included, if needed. A 3.5% Convenience fee is included in the cost as a cash advance item.

***Prepaid cremation packages are for future cremation needs. County fee and 2 death certificates are also included within these plans. These plans are available via the FSI Portal. No other services, or merchandise may be added to these fixed packages through the portal. Office hours: By appointment only. No weekends, no holidays. Arrangements paid prior to a death will be placed into a Funeral Trust Account. We utilize FSI – First Florida Trust. If arrangements are made in our office, we will refer to our Itemized General Price List for the goods and services which are selected and required during the arrangement conference. Cash advance items are not guaranteed.

The Federal Trade Commission requires the disclosure of costs of each individual funeral item and service offered. You are entitled to complete information via telephone, mail or personal inquiry. Under these regulations, those who offer Direct Cremation must tell you that Florida State Law does not require embalming, or the use of a casket for direct cremations.
