**RESOLUTION NO: SL - 68 - 2020**

**TITLE:       Amendment to Summit Lake Paiute Tribe's Property Management Manual**

**WHEREAS,** the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

**WHEREAS,** the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and

**WHEREAS,** a review of the updated 25 Code of Federal Regulations (25 CFR) for recording property management requirements when compared it to the Property Management Manual resulting in the need to amend the inventory and property policies; and

**WHEREAS,** The Tribal Council proposes the following clarification to policy of the recording requirements for property purchased with Federal agency awards, to enable the tribe to provide accountability of inventory and disposition of property while enabling personnel responsible for the preparation of inventory records to accurately prepare the Inventory Records according to requirements outlined in 25 CFR.

**WHEREAS,** the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe, to amend the Property Management Manual to include up to date federal regulations contained in 25 CFR §200.310 through §200.316 and 25 CFR §276.11; and

**NOW THEREFORE BE IT RESOLVED,** that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada, hereby submits the amended Property Management Manual, policy last amended on December 9, 2012 by Resolution No. SL-23-2012 and updated Locator Record Form.
