STRATTON SCHOOL BOARD MINUTES
JUNE 2, 2016

The Stratton School Board held its monthly meeting on Thursday, June 2, 2016 at the Stratton town office. The meeting was called to order at 7:05 P.M.

ATTENDING: Thomas Montemagni, Chairman, Siobhan Eddy Young, Director, Lorraine M. Weeks Newell, Secretary, Steven John, WCSU Superintendent and Ms. Juliana Moore.

MINUTES: The May 5, 2016 minutes were read. It was not stated in the minutes that no motions were made when the Board came out of Executive Session. With this correction noted, Lorraine Newell motioned to approve the minutes and Siobhan Young seconded.

OLD BUSINESS: Ms. Moore provided her renewed drivers license in order to complete her residency application. She first met with the Board at the December 3, 2015 meeting for the purpose of completing her Stratton Residency application for tuition assistance. With her information now complete as of the June 2, 2016 meeting, the Board will authorize payment to Twin Valley High School for tuition commencing from the time of her application, 12/3/2015 through to the end of the 2015/2016 school year.

ACT 46: WCSU Superintendent, Steven John, discussed questions and concerns the board has regarding Stratton's consolidation with other districts to form one school district or a RED which is the consolidation of three or more individual school districts to form one district.

The Stratton Board affirmed that they have joined in an Act 46 formal study to possibly form a RED which would include Stratton, Winhall, Searsburg and Sandgate. Stratton will also do an informal study for a possible side-by-side with Searsburg.
