April 29, 2022

DRAFT MINUTES Submitted by LD 3 Secretary Laurie Foster

Time: Credentials open at 6 PM, Call to Order at 7 PM Location: Pinnacle High School Cafeteria, 3535 East Mayo Blvd., Phoenix, AZ 85050

Call to Order: The meeting was called to order at 7:03 PM by Chairman Dr. Richard Rutkowski.

Invocation: Bob Gomez led the invocation

Pledge of Allegiance: Jerry Sheridan, former Chief Deputy of the Maricopa County Sheriff's Office, led the Pledge of Allegiance.

Welcome:

Chairman Richard Rutkowski welcomed and recognized current elected officials, state candidates, LD 3 officers were introduced and recognized. Time Keeper Tim Horn and Parliamentarian Dan Grimm were introduced. The Chairman thanked all volunteers at check in and proxy tables and ballot processing manager, George Teegarden and team.

Approval of Meeting Agenda:

A. Gerry Friedel moved to accept the meeting Agenda.

B. Jim O'Connor moved to add to the Agenda, prior to the adoption of bylaws, a discussion and vote to convert existing 5 voting members of the Bylaws Committee to a temporary committee to investigate standing committees and report back to the body. Michal Joyner 2nd the motion.

Chairman Rutkowski noted that all comments/suggestions submitted to the Bylaw Committee were considered in drafting the current proposed Bylaws.

C. Michal Joyner motioned to open up discussion on O'Connor's motion, Tim Horn 2nd the motion.

Chairman Rutkowski proposed that each member who would like to speak in discussion period will receive 1 min each, with a total of 5 minutes each side.
A voice vote was taken to approve the discussion and discussion format. Result of voice vote could not be established.

3. A hand count vote was taken, Joyner's motion for discussion passed.

4. In favor of Jim O'Connor's motion:

a) Tim Horn said expanding input into the board and expanding authority is very Republican thing to do, we need more standing committees.

b) Brian Ference recommended allowing further input from the Membership into the Bylaws.

c) Michal Joyner said that many suggestions were made to the existing Bylaw Committee, will give Committee chance to further analyze and come back to Membership with results.

d) Tracy Martin stated Bylaws need to be made precise and concise.

e) Jim O'Connor said what we are doing here is very American, upholds Republican ideals and that everyone who is participating in this process tonight is part of it, that we need more of us actively engaged in running this massive district

5. Opposed to O'Connor's motion:

a) Cathy Schwanke stated we have a good product, Bylaws should be concise, we need to get to business, move forward, not spend more time on Bylaws

D. Jim O'Connor restated his motion to add to the Agenda, before the adoption of the Bylaws, a discussion and then a vote to convert the existing 5 voting member Bylaw Committee into a temporary committee serving for one month to review and take suggestions on standing committees and current proposed bylaws and report back to this Body and then vote on the new bylaws.

1. Parliamentarian Dan Grimm stated and clarified our next action is to vote on amending the Agenda to insert Jim O'Connor's proposal/item.

2. Brian Ference proposed amending the motion to have a vote to refer the existing Bylaws Committee back to committee/action, Michal Joyner 2nd the motion.

3. Brian Ference moved that we dismiss discussion. There was no 2nd.

4. Ference withdrew his motion(s).

5. Kevin Maldonado, member of current Bylaws Committee, spoke on behalf of committee to clarify the actions of the Bylaws Committee leading up to tonight's meeting: Worked from the current proposed bylaws from the 3/31/22 LD 3 Reorg Meeting, all input from members/body was requested by Rich Rutkowski and submitted to him, committee hashed it out line by line, voted and came up with the current Proposed Bylaws to be presented and voted on tonight

6. A hand vote count of all Members was taken to approve adding Jim's agenda item. O'Connor's motion, 2nd by Michal Joyner passed and the Agenda will be modified.

E. Chairman Rutkowski identified a place in the agenda to insert Jim O'Connor's motion and a hand vote count of all members was taken to approve the newly modified Meeting Agenda of 4/29/22. Agenda as amended passed.

Approval of Meeting Rules:

Brenda Kalivianakis made motion to approve the Meeting Rules, 2nd by George Nemeh. Voice vote, Meeting Rules passed.

Credentials Report:

Cathy Schwanke reported 150 PCs in attendance, 66 Proxies for a total of 216. Quorum is 149, Quorum established

Amended Agenda Item:

A. Jim O' Connor moved to have the 5 voting member Bylaw Committee reassigned to a 30 day committee to review and take suggestions on standing committees and other aspects of the bylaws and report back to the Membership/Body and then vote on new Bylaws. Michel Joyner 2nd the motion.

1. Brief discussion for and against ensued, members noted current bylaws only allow chair to appoint committees, these committees need to be made more robust, complete

2. Chairman Rutkowski clarified to Membership: vote on motion to reconvene/reassign the current 5 member Bylaw Committee to meet, review bylaws, take input from Membership, prepare LD 3 Bylaws for report and proposal at a subsequent meeting, 30 days. Hand vote count, Jim O'Connor's motion passed.

Proposal for Adoption and Voting of LD 3 Bylaws:

Chairman Rutkowski stated no discussion or vote on Proposed Bylaws brought by Bylaw Committee tonight due to Jim O'Connor's passed motion.
