All rings will have baby gates. Although there is no separation of A & B classes, judges will use a B format in Utility/Open upon request. You may use toys, treats and training aids. No prong collars or harsh corrections will be allowed. When outside of the ring, dogs must be kept on leash or be crated. This match is open to both pure bred and All American dogs. Utility jump heights will run small to tall and Open jump heights will run tall to small.

**Pre-entry only: \$10 per entry (no 2nd run in the same class).**

**Entry limits: Utility, Open and Novice Obedience limited to 20 entries each,  
Beginner Novice limited to 12 entries, Rally limited to 40 entries**
