Pet Health Insurance



As some of you are aware, my Border Collie puppy, Rayne, was diagnosed with hip dysplasia in May of 2017. The diagnosis was a total shock. I had purchased pet insurance for him in August of 2016, when he was 8 weeks and 2 days old, not knowing how soon I would need and use it.

I did not send in my bills to the company right away. I thought hip dysplasia would not be covered because it is typically a hereditary diagnosis. I called the company and talked to a representative (on call 24/7) and was informed that I should send the bills. In three weeks, I received a check which covered 80% of Rayne's medical expenses. Rayne gets a shot of Adequan each month. The

shot's cost is \$31.00, and Pet Plan Insurance reimburses us for \$24.00 of that cost.

What I have learned with this diagnosis is that there is a period of grieving to go through. It was hard to find out that my 11-month-old pup was dysplastic. We were referred to a rehab vet in Pewaukee. Dr. Morgan and her staff of rehab techs are amazing! Rayne sailed through his rehab and will continue to do exercises to strengthen his hips on both sides for the rest of his life.

The other lesson that I learned was not to neuter Rayne at an early age. The rehab vet prefers not to neuter if there aren't issues with "raging hormones." This is because male dogs' testosterone is

considered a lean hormone and helps the dog maintain a healthy weight. Dogs and bitches do not respond to hormone replacement very well, so for now, we will leave Rayne intact, hoping this will continue to work for him.

The pet insurance company I chose is Pet Plan Company from Pennsylvania. Their website is GoPetPlan.Com. I know there are many plans out there, but we are so happy with Pet Plan, I wanted to share our story with all of you. Our Teka is also covered under this company. The rehab vet says this is one of the best plans she has worked with. I did a lot of research on this company before buying the plans. Just ask me any questions you might have!

Jefferson County Sheriff Thanks WWCDTC







Homemade Pumpkin Peanut Butter Dog Treats

Preheat oven to 350.

Ingredients:

½ cup natural peanut butter (fresh ground peanuts)

1 cup pureed pumpkin

½ tsp cinnamon

1 3/4 cup oat flour or whole wheat flour


Combine pumpkin and peanut butter

Store in refrigerator for about 5 days or freeze


