

An ordinance appropriating certain money's.

Be it ordained by the mayor and commissioners of the city of Garnett, Kansas,

Section One :- That the sum of Three Hundred and ninety two and 31/100 Dollars be and the same is hereby appropriated out of the General Fund in the hands of the city treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the 4th day of June 1917. a list of which may be found on page 4041 of the journal of the proceedings of the Board on said date.

Section Two :- that the sum of Six Hundred and Fifty nine and 7/100 Dollars be and the same is hereby appropriated out of the Water Works Fund in the hands of the city treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the 4th day of June 1917. a list of which may be found on page 41 of the journal of the proceedings of the Board on said date.

Section Three :- that the sum of Two Hundred and nineteen and 9/100 Dollars be and the same is hereby appropriated out of the Street Fund in the hands of the city treasurer to pay the bills allowed against said fund at ~~at xxxxxxxxxxxxxxxxxxxxxxx~~ a regular meeting of said Board held on the 4th day of June 1917. a list of which may be found on page 42 of the journal of the proceedings of the Board on said date.

Section Four :- that the sum of Five Hundred and Thirteen and 90/100 Dollars be and the same is hereby appropriated out of the Electric Light Fund in the hands of the city treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the 7th day of May 1917. a list of which may be found on page of the journal of the proceedings of the Board on said date.

~~Section Five :- that the sum of Dollars be and the same is hereby appropriated out of the Cemetery Fund in the hands of the city treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the 7th day of May 1917. a list of which may be found on page of the journal of the proceedings of the Board on said date.~~

Section ~~Five~~ Six :- that the sum of One and 70/100 Dollars be and the same is hereby appropriated out of the funds of sewer District No, (1) in the hands of the city treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the 4th day of June 1917. a list of which may be found on page 42 of the journal of the proceedings of the Board on said date.

Section ~~Seven~~ Six :- that the sum of One and 70/100 Dollars be and the same is hereby appropriated out of the funds of Sewer District No (2) in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 4th day of June 1917. a list of which may be found on page 42 of the journal of the proceedings of the Board on said date.

Section ~~Seven~~ Seven :- that the sum of One and 70/100 Dollars be and the same is hereby appropriated out of the funds of sewer District No, (3) in the hands of the city treasurer to pay the bills allowed against said fund on the 4th day of June 1917, a list of which may be found on page 42 of the journal of the proceedings of the Board on said date.

Section Eight That the sum of Three Hundred and Fifty Six and 15/100 Dollars be and the same is hereby appropriated out of the Paving Tax fund no 3 in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 4th day of June 1917. a list of which may be found on page 42 of the journal of the proceedings of the Board on said date.

Section Nine That the mayor and city clerk be and are hereby authorized and instructed to draw warrants on the city treasurer to pay the bills allowed in the foregoing sections of this ordinance.

Section Ten That this ordinance shall take effect and be in force from its passage by the Board of commissioners and its approval by the Mayor.
