YOUNG PEOPLE'S SURVEY

The Mirfield Matters Survey 2015 that the Planners agreed would still be acceptable needs to be added to by their direction in order to cover the views of Mirfield Youth. This to be targeted at 15 to 21 year olds; as those 18 to 21 now wouldn't have been old enough to take part in 2015. The Survey was perused and it was agreed that pages 104 to 111 were no longer appropriate as they referred to the Dewsbury & District Area Committee which is now defunct. The Mirfield Matters Survey was sent to Mirfield homes; but it is proposed that this one will be distributed via Social Media, Schools & Colleges. This will almost certainly be accessed by non-residents of Mirfield; so an extra question will be required at the outset. In addition the question about gender on page 116 will need to be expanded. The Planners views & suggestions about the changes to be sought
