

GOGEBIC COUNTY ROAD COMMISSION
2019 HMA PATCH PAVING SERVICES BID

Bid of _____ (hereinafter called "BIDDER"), organized and existing under the laws of the State of _____ doing business as _____*, to the Gogebic County Road Commission (hereinafter called "OWNER").

In compliance with your Advertisement for Bids, BIDDER hereby proposes to perform all work for the construction of 2019 HMA Patch Paving Services in accordance with the Contract Documents, within the time set forth herein, and at the prices stated below.

1. NOTICE TO BIDDERS

GCRC Bidding Instructions

The intent of the bid is to include all paving projects scheduled for work in Gogebic County. This includes areas of culvert patches and deteriorated areas. All work described below (including Measurement and Payment) shall be as described in the MDOT "2012 Standard Specifications for Construction" (Standard Specifications), except as modified herein. Mobilization shall be included in the bid items presented and will not be paid for separately.

Additional projects may be added to the proposal by the road commission as they arise throughout the summer. Negotiated cost will be agreed upon prior to any additional work being completed.

2. DESCRIPTION OF WORK

Machine Grading

After the maintenance gravel is removed to a depth of 3 inches relative to the adjacent roadway (Except for Planter Road – which will be 4 inches), the remaining gravel shall be graded and compacted. Patches will be saw cut by Contractor.

Machine Grading shall be paid for by the Syd, measured from shoulder hinge point to hinge point.

HMA, LVSP

HMA, LVSP shall include temporary maintenance gravel material, maintenance, and removal at the Patches between when the existing HMA is removed and the new HMA is paved.

The work shall consist of HMA, LVSP as shown in the typical sections. The work shall begin at Station 0+00 and run the entire length of the project. The work shall be completed in accordance with section 501 of the Standard Specifications for Construction. Refer to Special provision for Local Paving Project as attached.

1. For mainline paving projects – HMA application rate shall be two lifts at 165#/syd each (330# per syd total) paid by tons.
2. Planter Road: HMA application rate shall be two lifts at 220#/syd each (440# per syd total) paid by tons.
3. For overlay projects – HMA application rate shall be single lift at 220#/syd total paid by tons.
4. Performance Grade Asphalt shall be PG 52-34
5. Air Voids per MDOT Special Provision for Local Agency Projects 12SP-501J-05.

Maintaining Traffic, Minor Traffic Devices, Traffic Regulator Control, and Signage

Contractor shall be responsible for maintaining traffic, minor traffic devices, traffic regulator control and signage for the Contractor operation. Advance warning signage shall be in accordance with MDOT specification for lane closure or as agreed upon by the Engineer and Contractor. Traffic Regulator Control shall be provided during the operation of work with minor traffic devices used during construction and after working hours to provide safe travelable roadway for the public.

All Patches shall be constructed under traffic.

3. PROGRESS CLAUSE

Start work within ten (10) days after receiving notice of award of the contract or on or before the date designated as the starting date in the Detailed Progress Schedule. In no case, shall any work be commenced prior to receipt of formal notice of award by the department.

Completion Dates

All projects shall be completed in its entirety on or before **September 15, 2019**.

The approved low bidder(s) for the work covered by this proposal will be required to participate in a pre-construction meeting with local agency owner and/or department representatives to work out a detailed progress schedule. The schedule for this meeting will be set within one week after the contract is awarded.

The Gogebic County Road Commission will arrange the time and place for the meeting.

The Progress Schedule shall include, as a minimum, the controlling work items for the completion of the project and the planned dates (or work day for a work day project) that these work items will be controlling operations. When specified in the bidding proposal, the date the project is to be opened to traffic as well as the final project completion date shall also be included in the project schedule.

If the bidding proposal specifies other controlling dates, these shall also be included in the Progress Schedule.

4. METHOD OF MEASUREMENT AND PAYMENT

Measurement and payment shall be on the basis of the measured square yard, load ticket tonnage or lump sum quantities. The contractor shall measure the area with the Road Commission and submit an invoice for agreed quantity upon completion of all work.

6. BID DEADLINE

Sealed bids for the 2019 HMA Patch Paving Services will be received by the Gogebic County Road Commission, Courthouse Annex, Bessemer, MI 49911 until **11:00 A.M., central time on Tuesday, May 28, 2019**. All bids shall be publicly opened and read aloud at said office at that time.

7. INSURANCE

The Contractor shall not commence any work until they have obtained and provided a current Certificate of Insurance.

The Contractor shall carry "Public Liability Insurance" coverage to insure the Road Commission against claims arising out of negligence of the Contractor. The insurances shall meet all requirements as shown:

A. WORKERS COMPENSATION INSURANCE

The Contractor shall take out and maintain during the life of this contract, Workman's Compensation insurance for all of his employees employed at the site of the project and in case work is sub-contracted, the Contractor shall require the sub-contractor similarly to provide Workman's compensation insurance for all of the latter employees unless such employees are covered by the protection afforded by the Contractor.

By submission of this Bid, each party thereto certifies as to his/her own organization, that this Bid has been arrived at independently, without consultation, communication or agreement as to any matter relating to this Bid with any other Bidder or with any competitor.

The Board reserves the right to reject or accept any bid or all bids or to waive irregularities and to accept any bid that, in the opinion of the Board, is to the best interest and advantage of the County of Gogebic.

The BIDDER agrees to perform all described work in the Contract Documents for the following unit and/or lump sum prices. The BIDDER further agrees that the unit and/or lump sum prices include the furnishing of all labor, materials, tool, equipment, utilities, transportation, taxes, fees, etc., required to complete the work in strict accordance with the Contract Documents. The quantity shown in the Bid Schedule is an estimated minimum. If some of the optional sections are selected by the Townships, more will be added to the contract, but to be included in the two mobilizations.


